

SURVEYOR'S CERTIFICATE

I, RONALD A. QUIMBY, OREGON PROFESSIONAL LAND SURVEYOR NO. 1654, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION.

A PORTION OF PARCEL 1 OF LAND PARTITION 2000-0068 RECORDED IN THE DOUGLAS COUNTY CLERK PLAT RECORDS, LOCATED IN THE NORTHEAST QUARTER AND SOUTHEAST QUARTER OF SECTION 18, TOWNSHIP 27 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON, SAID PORTION BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 5/8 INCH IRON ROD AT THE SOUTHEAST CORNER OF LOT 12 OF ROCKY RIDGE P.U.D. 2, PHASE 1 RECORDED IN VOLUME 21, PAGE 34 OF THE DOUGLAS COUNTY PLAT RECORDS; THENCE RUNNING ALONG THE SOUTHERLY BOUNDARIES OF SAID ROCKY RIDGE P.U.D. 2, PHASE 1 THE FOLLOWING COURSES: NORTH 85°28'59" WEST 221.53 FEET, SOUTH 04°31'00" WEST 39.48 FEET, NORTH 85°14'20" WEST 160.20 FEET TO A 5/8 INCH IRON ROD AT THE SOUTHWEST CORNER OF LOT 21 OF SAID ROCKY RIDGE P.U.D. 2, PHASE 1; THENCE LEAVING SAID SOUTHERLY BOUNDARIES SOUTH 04°45'40" WEST 90.00 FEET; THENCE SOUTH 70°14'29" WEST 135.00 FEET; THENCE SOUTH 53°33'55" WEST 175.91 FEET; THENCE NORTH 89°36'18" WEST 90.01 FEET; THENCE NORTH 89°36'15" WEST 139.99 FEET TO A POINT ON THE EASTERLY BOUNDARY OF ROCKY RIDGE P.U.D. PHASE 1 RECORDED IN VOLUME 20, PAGE 36 OF THE DOUGLAS COUNTY PLAT RECORDS FROM WHICH A 5/8 INCH IRON ROD BEARS NORTH 09°07'41" WEST 295.54 FEET; THENCE RUNNING ALONG SAID EASTERLY BOUNDARY SOUTH 09°07'41" EAST 799.44 FEET; THENCE LEAVING SAID EASTERLY BOUNDARY SOUTH 83°29'21" EAST 387.98 FEET; THENCE NORTH 01°52'40" EAST 27.99 FEET; THENCE SOUTH 88°07'20" EAST 40.00 FEET; THENCE ALONG THE ARC OF A 320.00 FOOT RADIUS CURVE TO THE LEFT FOR 132.87 FEET (THE CHORD OF WHICH BEARS NORTH 10°01'03" WEST 131.92 FEET); THENCE SOUTH 84°15'54" EAST 222.62 FEET; THENCE NORTH 02°03'40" WEST 248.91 FEET; THENCE NORTH 13°08'11" EAST 413.41 FEET; THENCE NORTH 10°10'44" EAST 299.18 FEET TO THE POINT OF BEGINNING.

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO SUBDIVIDE THE ABOVE DESCRIBED PARCEL OF LAND INTO LOTS AS SHOWN HEREON. THE PROCEDURE WAS AS FOLLOWS: WE CHECKED AND USED EXISTING MONUMENTS AND CONTROL FROM OUR PREVIOUS SURVEYS "ROCKY RIDGE P.U.D. PHASE 1" AND "ROCKY RIDGE P.U.D. 2, PHASE 1" FOR CONTROLLING THIS SURVEY. MONUMENTS WERE SET TO DELINEATE LOTS AND PRIVATE ROADWAYS AS SHOWN.
