

SURVEYOR'S CERTIFICATE:

A PORTION OF THAT LAND DESCRIBED AS PARCEL 1 IN LAND PARTITION NUMBER 2001-0007 AS RECORDED IN DOUGLAS COUNTY SURVEY RECORDS, LYING IN THE NORTHWEST QUARTER OF SECTION 22, TOWNSHIP 28 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON.
