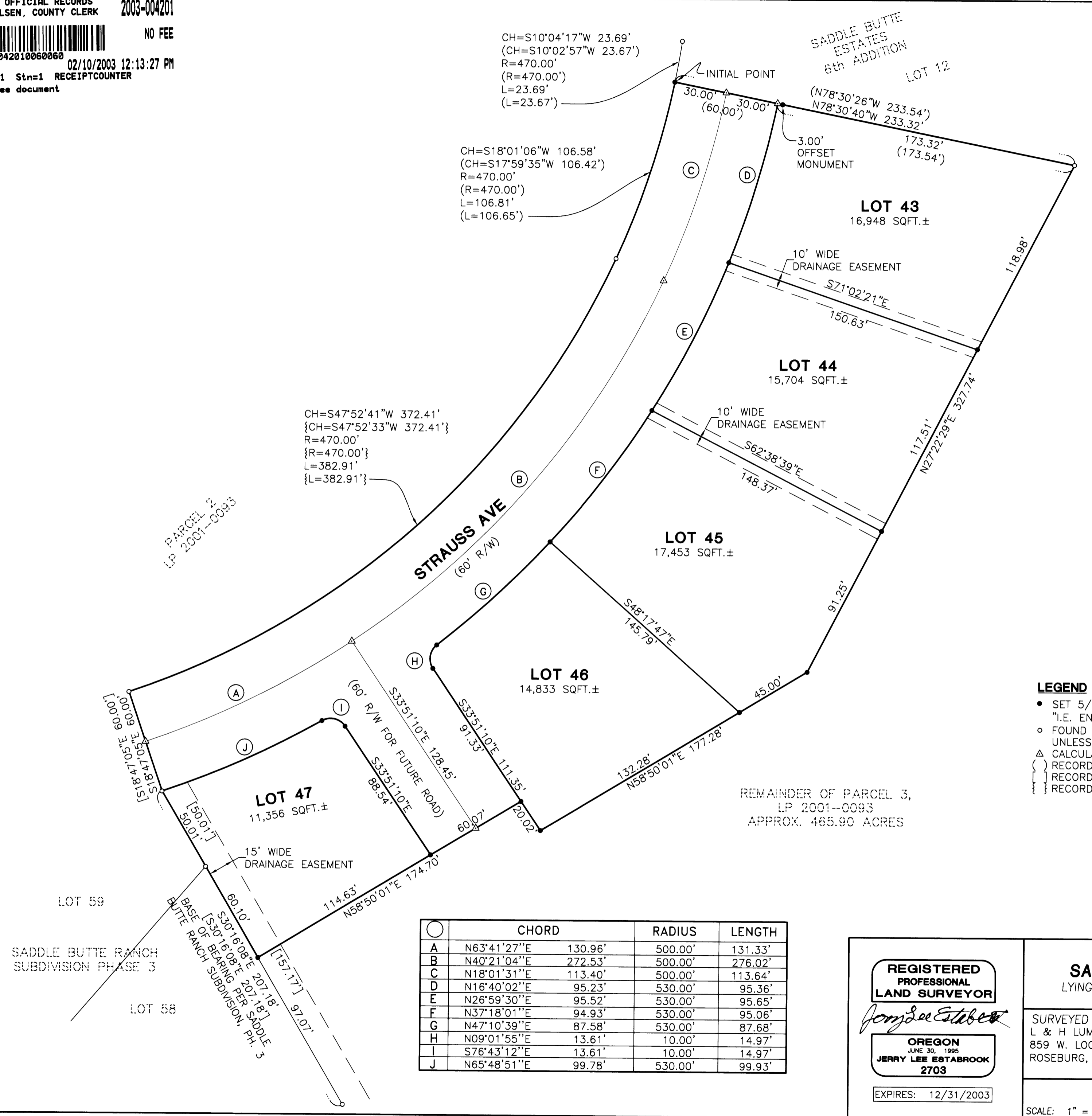

SURVEYOR'S CERTIFICATE

I, JERRY LEE ESTABROOK, BEING DULY SWORN, DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS. THE LAND SHOWN ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION.

A PORTION OF PARCEL 3 OF LP 2001-0093, DOUGLAS COUNTY SURVEY RECORDS, DOUGLAS COUNTY, OREGON. MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 5/8" IRON ROD ON THE COMMON BOUNDARY BETWEEN LOT 28 OF THE PLAT OF SADDLE BUTTE ESTATES SIXTH ADDITION AND THE WESTERLY RIGHT-OF-WAY BOUNDARY OF STRAUSS AVE.; THENCE SOUTH 78°30'40" EAST 233.32 FEET TO A 5/8" IRON ROD AT THE SOUTHEASTERLY CORNER OF LOT 12 OF SAID PLAT; THENCE SOUTH 27°22'29" WEST 327.74 FEET TO A 5/8" IRON ROD; THENCE SOUTH 58°50'01" WEST 177.28 FEET TO A 5/8" IRON ROD; THENCE NORTH 33°51'10" WEST 20.02 FEET TO A 5/8" IRON ROD; THENCE SOUTH 58°50'01" WEST 174.70 FEET TO A 5/8" IRON ROD ON THE NORTHEASTERLY BOUNDARY OF LOT 58 OF THE PLAT OF SADDLE BUTTE RANCH PHASE 3; THENCE NORTH 30°16'08" WEST 110.11 FEET TO A 5/8" IRON ROD AT THE NORTHEASTERLY CORNER OF LOT 59 OF SAID PLAT ALSO BEING A POINT ON THE SOUTHEASTERLY RIGHT-OF-WAY BOUNDARY OF STRAUSS AVE.; THENCE NORTH 18°47'05" WEST 60.00' TO A 5/8" IRON ROD ON THE NORTHWESTERLY RIGHT-OF-WAY BOUNDARY OF STRAUSS AVE.; THENCE NORTHEASTERLY ALONG A 470.00 FOOT RADIUS CURVE TO THE LEFT FOR 489.72 FEET (SAID CURVE HAVING A CHORD OF NORTH 41°21'56" EAST 467.86 FEET) TO THE POINT OF BEGINNING. CONTAINING 2.61 ACRES MORE OR LESS.

NARRATIVE

THE PURPOSE OF THIS MAP IS TO SUBDIVIDE A PORTION OF PARCEL 3 OF LP 2001-0093 INTO 6 LOTS AS SHOWN.

THE PROCEDURE WAS TO TIE AND HOLD MONUMENTS OF RECORD ON THE SOUTHWESTERLY, NORTHWESTERLY AND NORTHERLY BOUNDARIES OF THE AREA BEING SUBDIVIDED. I THEN ESTABLISHED THE SOUTHEASTERLY BOUNDARY BEING PLATTED AS SADDLE BUTTE ESTATES, 8TH ADDITION.
