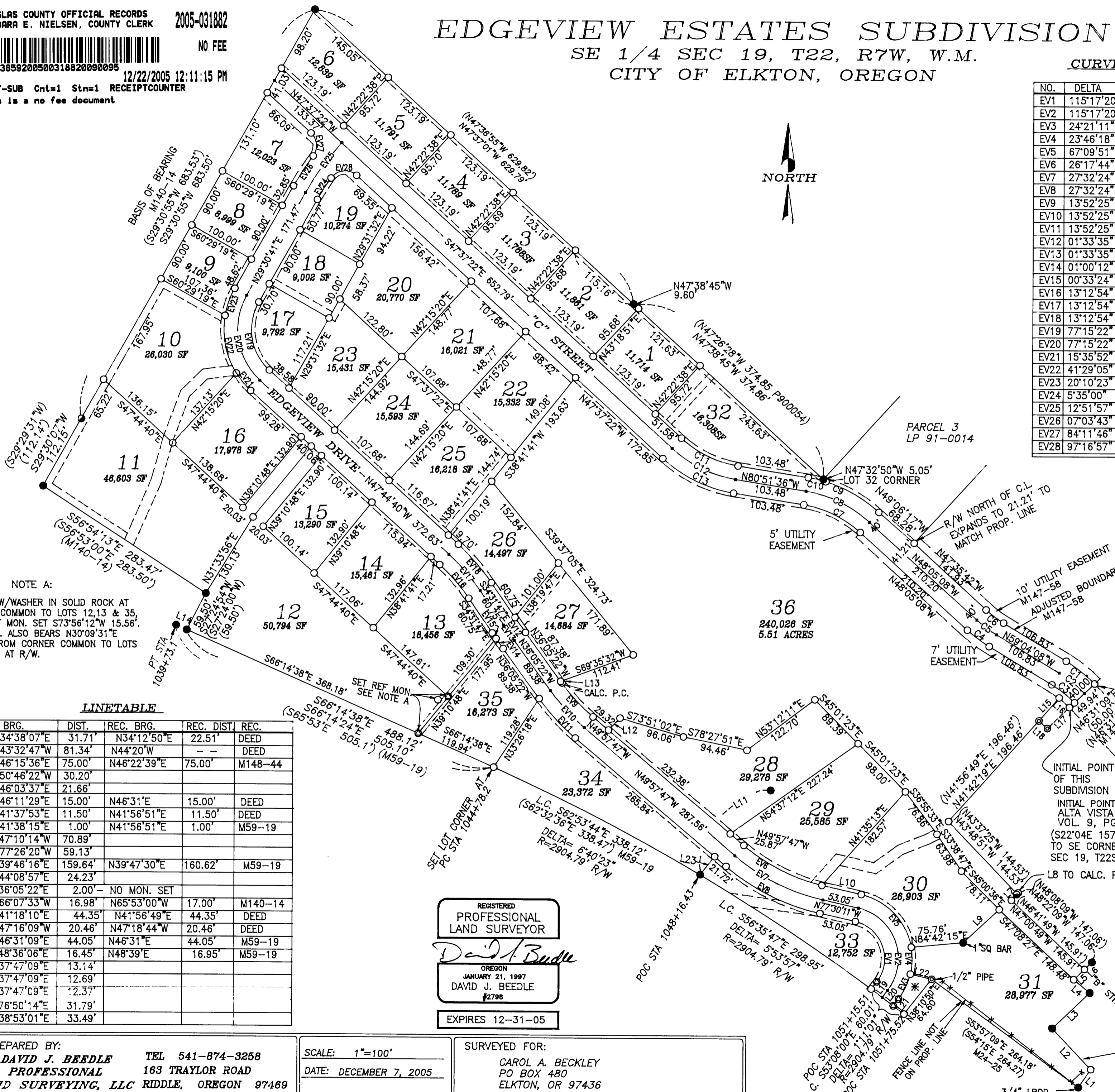

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO CREATE A SUBDIVISION ON THE PROPERTIES DESCRIBED IN DEED INSTRUMENTS 2000-19586, 2003-19482, 2003-19481, 2005-11509, AND A PORTION OF PARCEL 3 OF LAND PARTITION 1991-0014 OF DEED INSTRUMENT 2003-31238, ALL OF DOUGLAS COUNTY DEED RECORDS.

SURVEY MAPS M59-19, M24-25, M140-14, M147-58, M148-44, AND LAND PARTITION 1991-0014 WERE USED TO CONTROL THE PERIMETER OF THIS SURVEY.

THE NORTHERLY RIGHT OF WAY OF STATE HIGHWAY 38 WAS CONTROLLED BY STATE HIGHWAY DATA AND MONUMENTS FOUND PER M140-14, M59-19, AND M24-25.

LOT CORNERS ALONG THE WEST LINE OF LOT 35 FELL IN SOLID ROCK AND I COULD NOT SET NORMAL MONUMENTS ALONG THAT LINE. I SET A P.K. NAIL WITH A WASHER IN THE ROCK AT THE CORNER COMMON TO LOTS 12, 13, AND 35. I ALSO SET A REFERENCE MONUMENT NEARBY AS SHOWN ON THE FACE OF THE MAP.

THERE WAS A CONFLICT IN THE DEED CALLS ALONG THE SOUTH EAST LINE OF LOT 31 (L1). THE CALL TO THE SOUTH LINE OF LOT 6, BLOCK 14, FIRST ADDITION TO ELKTON, WAS HELD OVER DISTANCE.

THE SOUTH BOUNDARY OF LOT 31 DOES NOT CORRESPOND WITH THE EXISTING FENCE LINES.

THIS SURVEY WAS PERFORMED BY DAVID BEEDLE AND GAYLE BEEDLE USING A SOKKIA SET 4BII TOTAL STATION. CALCULATIONS AND DRAFTING BY DAVID BEEDLE.

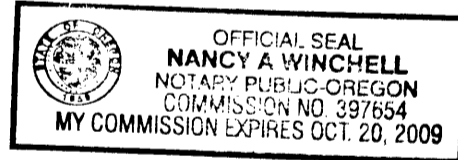
