



**SURVEYOR'S CERTIFICATE:**

I, RONALD A. QUIMBY, OREGON PROFESSIONAL LAND SURVEYOR NO. 1654, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION.

A PARCEL OF LAND CONSISTING OF A PORTION OF PARCELS 1, 2 AND 3 OF LAND PARTITION PLAT 2004-0004 OF THE DOUGLAS COUNTY PLAT RECORDS, BEING LOCATED IN THE SOUTHEAST AND SOUTHWEST QUARTERS OF SECTION 5, TOWNSHIP 30 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 3/4 INCH IRON PIPE AT THE SOUTHWEST CORNER OF SAID PARCEL 1 OF LAND PARTITION PLAT 2004-0004; THENCE ALONG THE WEST BOUNDARY LINE OF SAID PARCEL 1 NORTH 02°53'34" EAST 258.40 FEET TO A 3/4 INCH IRON PIPE; THENCE CONTINUING ALONG SAID WEST BOUNDARY NORTH 03°02'04" EAST 61.40 FEET TO A 3/4 INCH DIAMETER IRON PIPE; THENCE CONTINUING ALONG SAID WEST BOUNDARY NORTH 41°08'47" EAST 48.60 FEET TO A 5/8 INCH IRON ROD ON THE SOUTHERLY BOUNDARY LINE OF THAT LAND DESCRIBED IN INSTRUMENT 2004-010888 OF THE DOUGLAS COUNTY DEED RECORDS; THENCE ALONG THE SOUTHERLY BOUNDARY OF SAID LAND SOUTH 48°51'13" EAST 10.00 FEET TO A 5/8 INCH IRON ROD; THENCE ALONG THE EAST BOUNDARY OF SAID LAND NORTH 41°08'47" EAST 125.28 FEET TO A 5/8 INCH IRON ROD ON THE SOUTH BOUNDARY OF THAT LAND DESCRIBED IN INSTRUMENT NUMBER 2005-030675 AS RECORDED IN THE DOUGLAS COUNTY DEED RECORDS; THENCE ALONG SAID SOUTH BOUNDARY SOUTH 48°52'51" EAST 120.00 FEET TO A 5/8 INCH IRON ROD AT THE SOUTHEAST CORNER OF SAID LAND DESCRIBED IN INSTRUMENT NUMBER 2005-030675; THENCE ALONG THE EAST BOUNDARY OF SAID LAND DESCRIBED IN INSTRUMENT NUMBER 2005-030675 NORTH 41°08'47" EAST 59.47 FEET TO A 5/8 INCH IRON ROD; THENCE CONTINUING ALONG SAID EAST BOUNDARY ALONG THE ARC OF A 20.00 FOOT RADIUS CURVE TO THE LEFT FOR 31.59 FEET (THE CHORD OF WHICH BEARS NORTH 04°06'00" WEST 28.41 FEET) TO A 5/8 INCH IRON ROD ON THE NORTHERLY BOUNDARY OF SAID PARCEL 1 OF LAND PARTITION PLAT 2004-0004; THENCE ALONG SAID NORTHERLY BOUNDARIES OF SAID PARCELS 1 AND 3 OF SAID LAND PARTITION PLAT 2004-0004 ALONG THE ARC OF A 259.18 FOOT RADIUS CURVE TO THE LEFT FOR 89.15 FEET (THE CHORD OF WHICH BEARS SOUTH 59°12'00" EAST 88.71 FEET TO A 5/8 INCH IRON ROD ON THE NORTHERLY BOUNDARY OF THAT LAND DESCRIBED IN INSTRUMENT NUMBER 2005-030674 AS RECORDED IN THE DOUGLAS COUNTY DEED RECORDS; THENCE ALONG THE WESTERLY BOUNDARY OF SAID LAND DESCRIBED IN INSTRUMENT NUMBER 2005-030674 ALONG THE ARC OF A 20.00 RADIUS CURVE TO THE LEFT FOR 24.36 FEET (THE CHORD OF WHICH BEARS SOUTH 76°02'47" WEST 22.89 FEET TO A 5/8 INCH IRON ROD; THENCE CONTINUING ALONG SAID WESTERLY BOUNDARY SOUTH 41°08'47" WEST 0.74 FEET TO A 5/8 INCH IRON ROD; THENCE CONTINUING ALONG SAID WESTERLY BOUNDARY SOUTH 19°22'37" EAST 142.85 FEET TO A 5/8 INCH IRON ROD AT THE SOUTHWEST CORNER OF SAID LAND DESCRIBED IN INSTRUMENT NUMBER 2005-030674; THENCE ALONG THE SOUTH BOUNDARY OF SAID LAND DESCRIBED IN INSTRUMENT NUMBER 2005-030674 SOUTH 88°55'23" EAST 5.34 FEET TO A 5/8 INCH IRON ROD AT THE SOUTHWEST CORNER OF SAID PARCEL 3 OF SAID LAND PARTITION PLAT 2004-0004; THENCE ALONG THE SOUTH BOUNDARY OF SAID PARCEL 3 OF SAID LAND PARTITION PLAT 2004-0004 SOUTH 88°55'23" EAST 52.53 FEET TO A 5/8 INCH IRON ROD AT THE SOUTHWEST CORNER OF PARCEL 2 OF LAND PARTITION PLAT 2003-0015 AS RECORDED IN THE DOUGLAS COUNTY PLAT RECORDS; THENCE ALONG THE SOUTH BOUNDARY OF SAID PARCEL 2 OF SAID LAND PARTITION PLAT 2003-0015 SOUTH 88°52'19" EAST 79.98 FEET TO A 5/8 INCH IRON ROD AT THE SOUTHWEST CORNER OF PARCEL 3 OF SAID LAND PARTITION PLAT 2003-0015; THENCE ALONG THE SOUTH BOUNDARY OF SAID PARCEL 3 SOUTH 88°49'53" EAST 89.69 FEET TO A 5/8 INCH IRON ROD AT THE SOUTHEAST CORNER OF SAID PARCEL 3; THENCE ALONG EAST BOUNDARY OF SAID PARCEL 1 OF SAID LAND PARTITION PLAT 2004-0004 SOUTH 01°51'15" WEST 227.08 FEET TO A 5/8 INCH IRON ROD AT THE SOUTHEAST CORNER OF SAID PARCEL 1; THENCE ALONG THE SOUTH BOUNDARY OF SAID PARCEL 1 SOUTH 88°01'30" WEST 587.12 FEET TO THE POINT OF BEGINNING AND CONTAINING 4.29 ACRES MORE OR LESS.
