I, BRENT H. KNAPP, OREGON PROFESSIONAL LAND SURVEYOR NO. 81116, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THE ANNEXED PLAT OF WHICH THE FOLLOWING IS A TRUE AND CORRECT DESCRIPTION:

PARCELS 1 AND 2 OF LAND PARTITION NO. 2005-0093, DEED RECORDS OF DOUGLAS COUNTY LOCATED IN THE SOUTHWEST OF THE NORTHEAST QUARTER OF SECTION 33, TOWNSHIP 29 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON.

THE ABOVE DESCRIBED TRACT CONTAINS 5.20 ACRES, MORE OR LESS

NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO SUBDIVIDE PARCELS 1 AND 2 OF LAND PARTITION NO. 2005-0093, PLAT RECORDS OF DOUGLAS COUNTY, INTO 12 LOTS AS SHOWN. THE PROCEDURE WAS AS FOLLOWS:

THE INITIAL POINT OF THE SUBDIVISION IS THE FOUND 2-INCH IRON PIPE AT THE SOUTHWEST CORNER OF SAID PARCEL 1. FOUND MONUMENTS PER SAID PARTITION PLAT 2005-0093 AND THE RECORD SURVEY M155-47 WERE TIED AND HELD AS SHOWN. THE SOUTHEAST CORNER OF SAID PARCEL 2 WAS TIED DURING THE INITIAL BOUNDARY SURVEY OF THE SUBJECT TRACT, BUT WAS DESTROYED DURING CONSTRUCTION. IT WAS REPLACED AT THE ORIGINAL COORDINATES WITH A MAG NAIL AND WASHER AS NOTED ON SHEET 1. THE ANGLE POINT ON THE SOUTHERLY BOUNDARY OF LOT 13, CAMELOT SUBDIVISION, VOLUME 23, PAGE 24, PLAT RECORDS OF DOUGLAS COUNTY, WAS DESTROYED DURING CONSTRUCTION AND REPLACED USING THE INITIAL BOUNDARY SURVEY COORDINATES, NOTED ON SHEET 1. MONUMENTS WERE SET AT THE NEW LOT CORNERS AS SHOWN.
