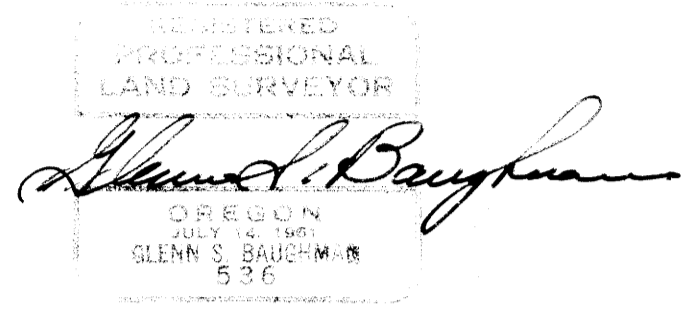

PARCEL 1

Beginning at a 1/2" Iron Rod from which the South one-sixteenth corner common to Sections 31 and 32, T. 28 S., R. 7 W., W.M., bears S 64°45'38" E 266.98 feet and N 88°31'35" E 339.53 feet and N 88°01'55" E 1,447.20 feet; thence N 64°45'38" W 180.00 feet to a 1/2" Iron Rod on the Easterly right-of-way line of Oregon State Highway No. 42, thence along an arc of a 663.30 foot radius curve right (the long chord of which bears N 29°37' E) 309.17 feet to a 1/2" Iron Rod; thence leaving said Easterly right-of-way line S 35°38' E 199.19 feet to a 1/2" Iron Rod; thence S 30°00' W 212.04 feet to the Point of Beginning, situated in Section 31, T. 28 S., R. 7 W., W.M., containing 1.16 acres, more or less.

PARCEL 2

Beginning at a 5/8" Iron Rod at the Southwest corner of the lands conveyed to Ernest T. Schosso, et al, in Volume 171, Recorder's No. 96414, Deed Records of Douglas County Oregon, from which the South one-sixteenth corner common to Sections 31 and 32, T. 28 S., R. 7 W., W.M., bears N 88°01'55" E 1,447.20 feet; thence S 88°31'35" W 260.47 feet to a point in the center of Ten Mile Creek; thence S 65°41'35" W along the center of said creek 46.70 feet to a point; thence leaving said creek N 64°45'38" W 307.30 feet to a 1/2" Iron Rod; thence N 30°00' E 212.04 feet to a 1/2" Iron Rod; thence N 35°38' W 199.19 feet to a 1/2" Iron Rod on the Easterly right-of-way line of Oregon State Highway No. 42, thence along said Easterly right-of-way line, on an arc of a 663.30 foot radius curve right (the long chord of which bears N 44°32'39" E) 33.53 feet to a 5/8" Iron Rod; thence N 44°00'35" W 20.00 feet to a 5/8" Iron Rod; thence N 45°59'25" E 250.35 feet to a 1/2" Iron Rod; thence leaving said Easterly right-of-way line S 44°00'35" E 170.00 feet to a 1/2" Iron Rod; thence S 41°11'13" W 102.93 feet to a 1/2" Iron Rod; thence S 13°49'25" W 20.95 feet to a 1/2" Iron Rod; thence S 32°42' E 109.55 feet to a 1/2" Iron Rod; thence N 59°52'14" E 297.44 feet to a 1/2" Iron Rod, on the West line of the aforementioned Schosso, et al, lands; thence S 4°31' E 501.46 feet along said West line to the Point of Beginning, situated in Section 31, T. 28 S., R. 7 W., W.M., containing 5.83 acres, more or less.
