A PARCEL OF LAND LYING IN SECTION 1, TOWNSHIP 29 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN, SAID PARCEL BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A 1/2" IRON ROD WHICH IS NORTH 88°-58'-25" EAST 680.40 FEET FROM A 1" IRON PIPE AT THE CENTER QUARTER OF SAID SECTION 1; THENCE NORTH 0°-26'-27" WEST 506.81 FEET TO A 1/2" IRON ROD; THENCE NORTH 88°-53'-32" EAST (NORTH 88°-54'-12" EAST PER BOOK 581, PAGE 925, DOUGLAS COUNTY DEED RECORDS) 348.13 FEET TO A 1/2" IRON ROD; THENCE SOUTH 617.11 FEET TO A 1/2" IRON ROD ON THE NORTHERLY RIGHT-OF-WAY OF COUNTY ROAD NO. 105; THENCE ALONG SAID RIGHT-OF-WAY SOUTH 60°-47'-41" WEST 93.04 FEET TO A 5/8" IRON ROD; THENCE SOUTH 62°-30'-00" WEST 168.06 FEET TO A 5/8" IRON ROD; THENCE 15.22 FEET ALONG THE ARC OF A 1105.92 FOOT RADIUS CURVE RIGHT HAVING A CHORD BEARING SOUTH 61°-11'-35" WEST 15.22 FEET TO A 1/2" IRON ROD; THENCE LEAVING SAID RIGHT-OF-WAY NORTH 235.72 FEET TO A 5/8" IRON ROD; THENCE SOUTH 88°-58'-25" WEST 100.56 FEET TO THE POINT OF BEGINNING, CONTAINING 5.00 ACRES MORE OR LESS.

A PARCEL OF LAND LYING IN SECTION 1, TOWNSHIP 29 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN, SAID PARCEL BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE CENTER ONE-QUARTER CORNER OF THE ABOVE SAID SECTION 1; THENCE ALONG THE NORTH-SOUTH CENTERLINE OF SAID SECTION 1, NORTH 0°-26'-23" WEST 505.84 FEET TO A 5/8" IRON ROD; THENCE NORTH 88°-53'-32" EAST (NORTH 88°-54'-12" EAST PER BOOK 581, PAGE 925, DOUGLAS COUNTY DEED RECORDS) 680.40 FEET TO A 1/2" IRON ROD; THENCE SOUTH 0°-26'-27" EAST 506.81 FEET TO A 1/2" IRON ROD; THENCE SOUTH 88°-58'-25" WEST 680.40 FEET TO THE POINT OF BEGINNING, CONTAINING 7.90 ACRES MORE OR LESS.

THE CENTER LINE OF A 25 FOOT ACCESS EASEMENT DESCRIBED AS FOLLOWS: BEGINNING AT A POINT WHICH IS NORTH 88°-58'-25" EAST 680.40 FEET AND NORTH 0°-26'-27" WEST 25.00 FEET FROM THE CENTER ONE-QUARTER OF SECTION 1, TOWNSHIP 29 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON; THENCE RUNNING NORTH 88°-58'-31" EAST 133.75 FEET; THENCE SOUTH 53°-56'-35" EAST 73.87 FEET; THENCE SOUTH 14°-01'-10" WEST 87.71 FEET; THENCE SOUTH 40°-32'-20" WEST 71.49 FEET; THENCE SOUTH 65.00 FEET TO THE NORTHERLY RIGHT-OF-WAY OF COUNTY ROAD NUMBER 105.
