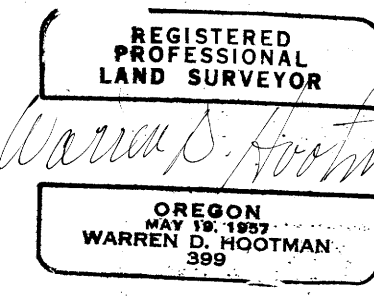


FOREST PARK TOWNHOUSE TRACT

Hootman, being duly sworn, depose and say that I have correctly surveyed and marked with proper monuments the land shown on the annexed plat, of which the following is a true description: A tract of land lying on the Easterly edge of Ranch Road as described in the Plat of Forest Hills First Addition Volume 330, Page 112, Deed Records of Douglas County, Oregon and more particularly described as follows: Beginning at a point which bears South 97° 25' feet and West 2772.09 feet from the Northeast Corner of Section 4, Township 22 South, Range 12 West, Willamette Meridian thence N 65° 25' E, 90.0 feet; thence N 24° 35' W, 308.0 feet; thence N 60° 31' W, 94.9 feet; thence N 27° 38' W, 80.0 feet; thence S 62° 22' W, 126.35 feet; thence S 27° 38' E, 157.50 feet; thence S 44° 53' E, 253.0 feet; thence S 24° 35' E, 63.45 feet to the point of beginning.

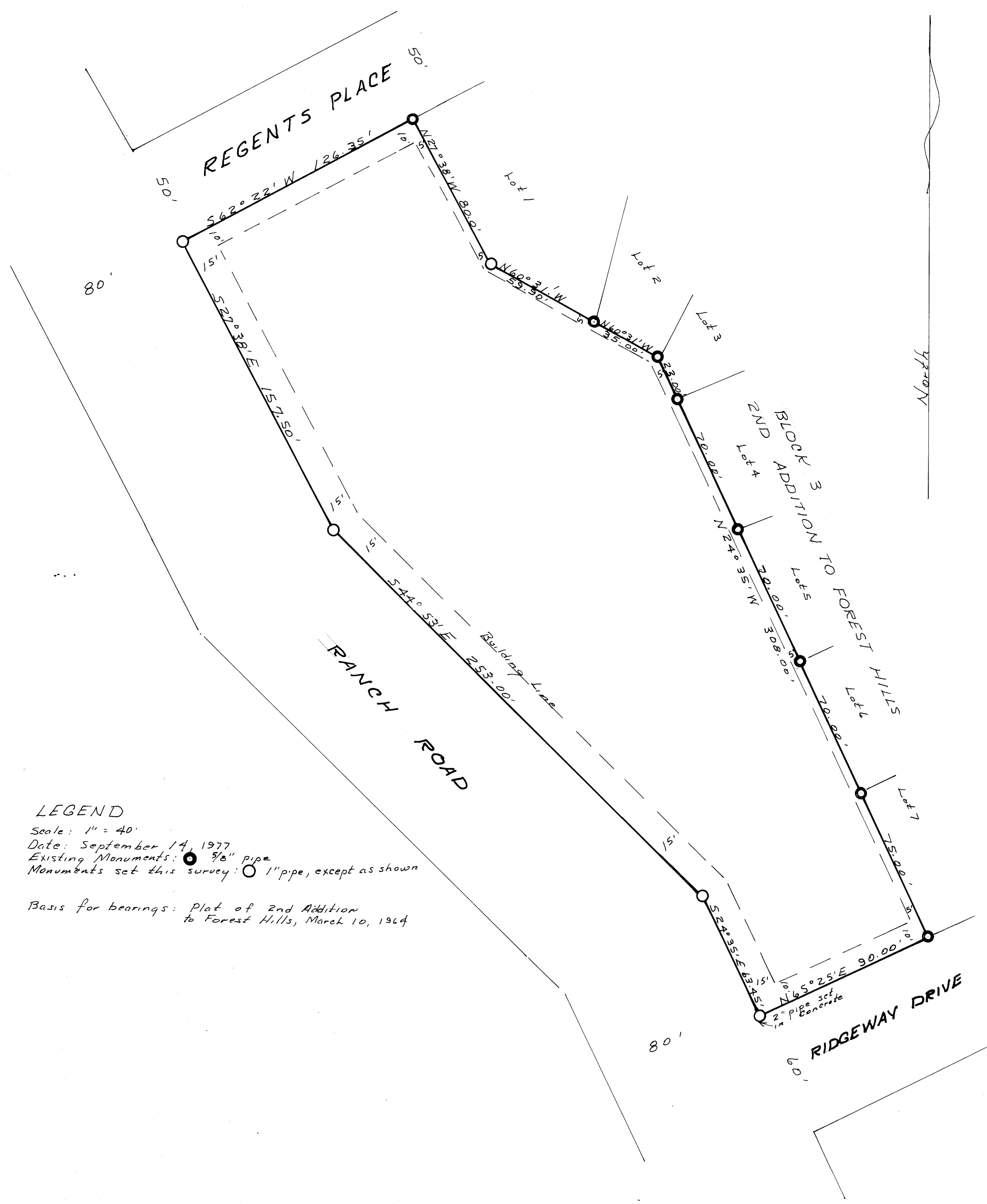
