PARCEL 1.

A PART OF LOT 10, 4TH ADDITION TO BRIGGS ACRES IN THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 33, TOWNSHIP 29 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON, MORE FULLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 1/2" IRON ROD AT THE NORTHWESTERLY CORNER OF SAID LOT 10; THENCE SOUTH 31°-50'-40" EAST 169.03 FEET ALONG THE SOUTHWESTERLY SIDE OF SAID LOT 10 TO A POINT; THENCE NORTH 41°-41'-35" EAST 100.11 FEET TO A 1/2" IRON ROD ON THE NORTHEASTERLY SIDE OF SAID LOT 10; THENCE NORTH 31°-50'-40" WEST 163.00 FEET ALONG SAID SIDE OF LOT 10 TO A 1/2" IRON ROD AT THE NORTHEASTERLY CORNER OF SAID LOT 10; THENCE SOUTH 45°-03'-20" WEST 98.57 FEET ALONG THE NORTHWESTERLY SIDE OF SAID LOT 10 TO THE POINT OF BEGINNING, CONTAINING 0.366 ACRES MORE OR LESS.

BEGINNING AT A POINT WHICH BEARS SOUTH 31°-50'-40" EAST 169.03 FEET ALONG THE SOUTHWESTERLY SIDE OF SAID LOT 10 FROM A 1/2" IRON ROD AT THE NORTHWESTERLY CORNER OF SAID LOT 10; THENCE SOUTH 31°-50'-40" EAST 120.06 FEET ALONG THE SOUTHWESTERLY SIDE OF SAID LOT 10 TO A 1" IRON ROD; THENCE NORTH 40°-41'-35" EAST 16.01 FEET TO A 1/2" IRON ROD; THENCE NORTH 40°-41'-35" EAST 84.81 FEET TO A 1/2" IRON ROD ON THE NORTHEASTERLY SIDE OF SAID LOT 10; THENCE NORTH 32°-10'-25" WEST 31.86 FEET ALONG SAID SIDE OF LOT 10 TO A 1/2" IRON ROD; THENCE NORTH 31°-50'-40" WEST 86.32 FEET ALONG SAID SIDE OF LOT 10 TO A 1/2" IRON ROD; THENCE SOUTH 41°-41'-35" WEST 100.11 FEET TO THE POINT OF BEGINNING, CONTAINING 0.263 ACRES MORE OR LESS.
