BEGINNING at a 5/8" iron rod at the northwest corner of the Arthur and Margaret Webber property, c/o James E. and Shirley A. Thompson, as described in Instr. No. 77-12790 of Douglas County Records, being on the southerly R/W line of County Road No. 140 and from which the 1/4 corner between Sections 6 and 7, T 29 S, R 7 W, W. M. bears N 61°36'26" E 1116.91 ft., thence along said R/W line on the following courses: N 72°55'52" W 72.29 ft. and N 74°28'38" W 741.21 ft. to a 1 1/2" iron pipe, thence leaving said R/W line and running S 36°30'00" W 417.58 ft. to a 5/8" iron rod, thence S 33°06'49" E 263.04 ft. to a 5/8" iron rod, thence N 82°54'52" E 852.93 ft. to a 5/8" iron rod at an interior corner on the westerly line of said Webber et al. property, thence N 10°11'45" E along the westerly line of said Webber et al. property 234.94 ft. to the point of beginning, containing 8.65 acres, more or less;

M. bears N 53°20'13" E 1276.68 ft., thence S 82°54'52" W 852.93 ft. to a 5/8" iron rod, thence S 28°11'32" W 136.69 ft. to a 5/8" iron rod, thence S 73°30'51" W 131.08 ft. to a 5/8" iron rod, thence S 26°00' E 485.07 ft. to a 5/8" iron rod on the westerly line of said Webber et al. property, thence N 49°41'57" E 1080.49 ft. along said westerly line of said Webber et al. property to the point of beginning, containing 6.98 acres, more or less;
