A parcel of land lying in Section 34, Township 30 South, Range 5 West, Willamette Meridian and being described as follows: Beginning at a 5/8" iron rod set in the easterly line of a 60 foot dedicated road, said point being also on the north line of that certain 50 foot easement as described in Instrument No. 78-23268 in the Deed Records of Douglas County, Oregon and from which the southeast corner of D.L.C. 59 in the above said Township and Range bears S 25° 23' 09" W 706.72 feet; thence along said north line S 45° 00' E 32.97 feet to a 5/8" iron rod and N 82° 55' E 414.29 feet to a 5/8" iron rod set in the center of that certain water ditch as described in Volumn 16, Page 550 in the Deed Records of Douglas County, Oregon; thence along the centerline of said ditch S 32° 44' 59" W 58.80 feet to a 5/8" iron rod, S 45° 01' 38" W 165.03 feet to a 5/8" iron rod, S 21° 53' 09" W 37.87 feet to a 5/8" iron rod and S 34° 29' 28" E 27.57 feet to a 5/8" iron rod; thence leaving said centerline S 66° 37' 28" W 43.40 feet to a 5/8" iron rod at the northeast corner of that property as described in Instrument No. 77-21273 in the Deed Records of Douglas County, Oregon; thence along the north line of said property S 84° 20' 55" W 313.93 feet to a 5/8" iron rod set in the east line of the old Pacific Highway; thence along said east line along the arc of a 746.20 foot radius curve to the left (the long chord of which bears N 18° 25' 15" W) 166.18 feet to a 5/8" iron rod set in the south line of a 60 foot dedicated street; thence along said south line and along the easterly line of the above said 60 foot dedicated street N 65° 18' E 97.63 feet to a 5/8" iron rod and N 31° 44' 30" E 54.30 feet to the point of beginning and containing 2.076 acres of land.

Together with and subject to that certain 50 foot easement as described in Instrument No. 78-23268 in the Deed Records of Douglas County, Oregon.
