PARCEL No. 1

Beginning at a stone, marked with an "X" on top, from which the Southeast corner of D.L.C. No. 39, Township 22 South, Range 7 West, W.M. bears S 89°05'09" E 2034.56 feet; thence N 89°05'09" W along the Southerly line of D.L.C. No. 39, 205.08 feet to a point; thence leaving said southerly line, N 18°43' W 433.82 feet to a 5/8" iron rod; thence N 77°41'30" E 191.95 feet to a 5/8" iron rod on the westerly R/W line of County Road No. 10 (as built); thence S 18°43' E along said westerly R/W line 423.10 feet to a 5/8" iron rod and S 21°05'30" E 58.24 feet to the Point of Beginning, situated in Section 29, Township 22 South, Range 7 West W.M., containing 2.00 acres, more or less.

Gates and wife by Recorder's No. 65-3458, Deed Records of Douglas County, Oregon; thence N 77°20' E along the Southerly line of said Gates property 117.33 feet to a 1/2" iron pipe being the Northwesterly corner of the land conveyed to Phillip L. Beckley by Recorder's No. 65-9557, Deed Records of Douglas County, Oregon; thence S 4°02'50" E along said Beckley property line 208.21 feet to a fence post being the Southwest corner thereof, said point also being the Northwesterly corner of the Cemetery deeded to the Probate Judge and his successors in office by Volume 45, Page 548, Deed Records of Douglas County, Oregon; thence along said cemetery boundary lines S 12°27'05" E 208.71 feet to a fence post and N 77°41'30" E 233.14 feet to a 5/8" iron rod on the Westerly R/W line of County Road No. 10 (as built); thence S 18°43' E along said Westerly R/W line, 25.16 feet to a 5/8" iron rod; thence leaving said Westerly R/W line, S 77°41'30" W 191.95 feet to a 5/8" iron rod; thence S 74°14'56" W 309.15 feet to the Point of Beginning, situated in Section 29, Township 22 South, Range 7 West, W.M., containing 2.01 acres, more or less.

No. 39, Township 22 South, Range 7 West, W.M. bears S 89°05'09" E 2725.87 feet; thence N 8°48'04" E along said Easterly R/W line, 323.00 feet to a 5/8" iron rod; thence leaving said Easterly R/W line N 74°14'56" E 309.15 feet to a 5/8" iron rod; thence S 18°43' E 433.82 feet to a point on the Southerly line of said D.L.C. No. 39; thence N 89°05'09" W along said Southerly R/W line, 486.23 feet to the Point of Beginning, situated in Section 29, Township 22 South, Range 7 West, W.M., containing 3.32 acres, more or less.
