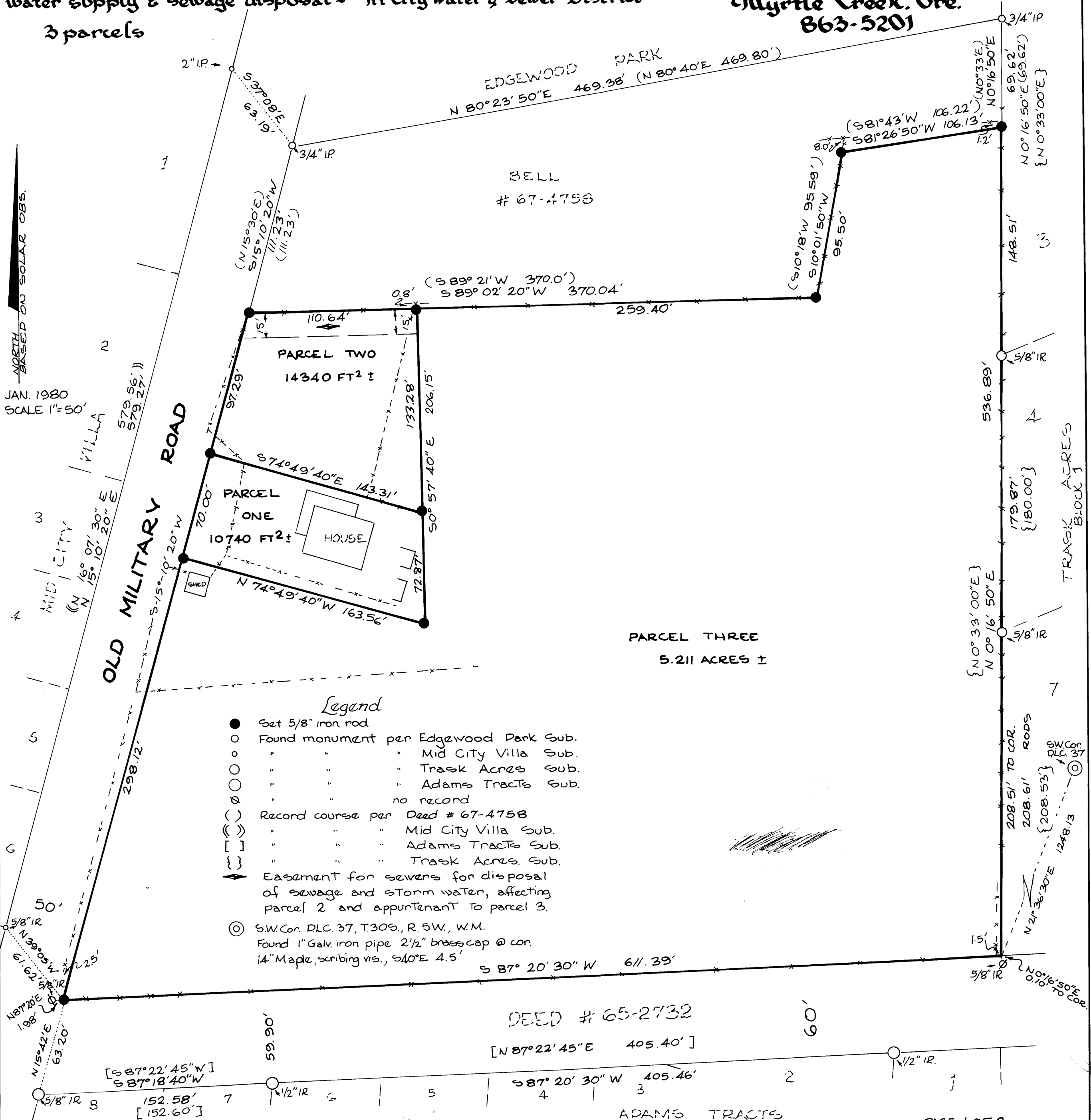

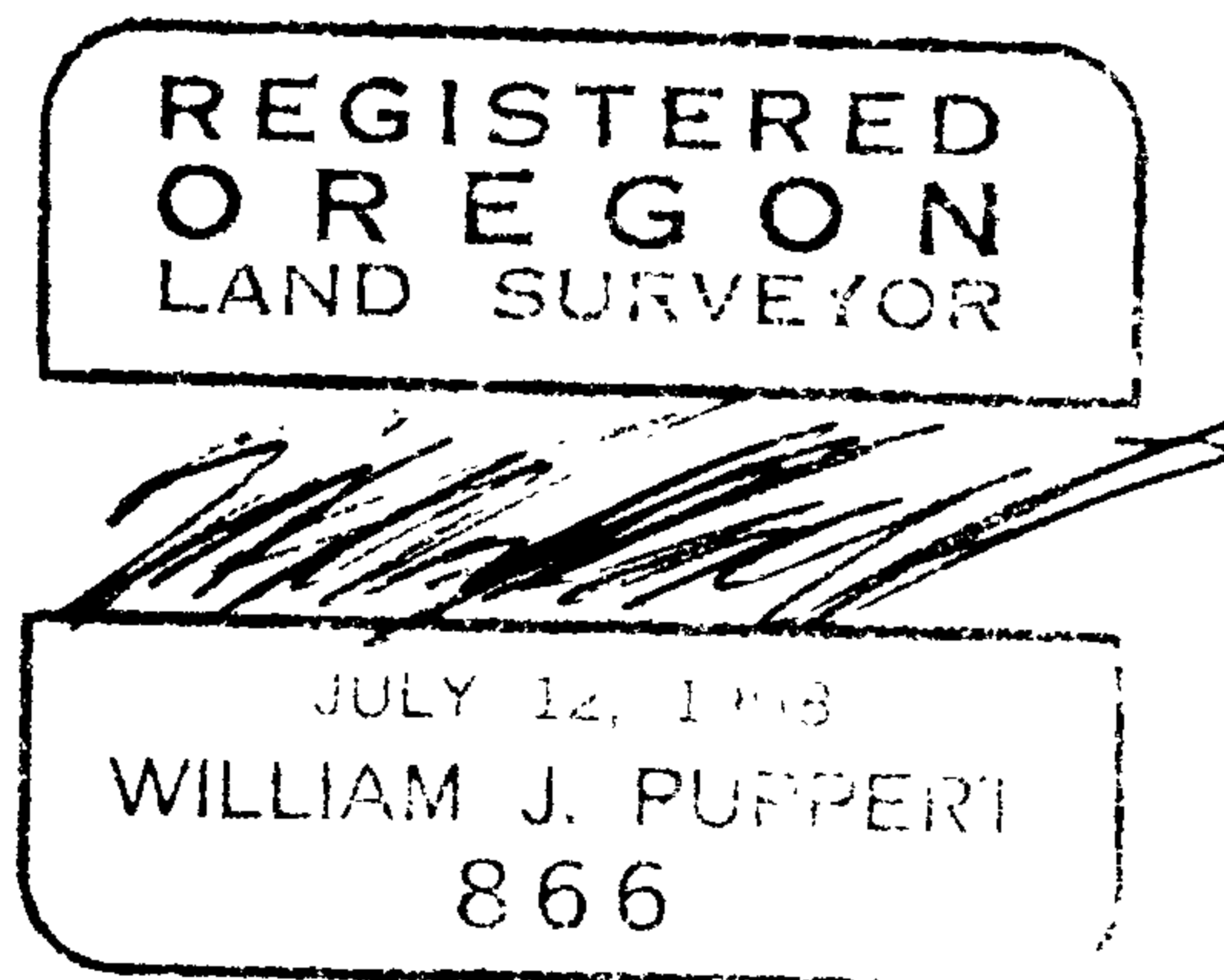

HISTORY: THIS LAND IS THE REMAINDER OF THE LANDS CONVEYED TO FRED WEAVER BY DEEDS #44172 AND VOLUME 79, PAGE 321. THIS SURVEY REFLECTS THE EXCEPTIONS.

PROCEDURE: LEITZ T60D & BEETLE 1000S EDM WERE USED FOR RANDOM TRAVERSE AROUND PERIMETER. BASIS OF BEARING IS BY SOLAR OBSERVATION, TIME METHOD, USING QUARTZ LCD WATCH CHECKED TO SHORT-WAVE RADIO BROADCAST. THE SOUTHERLY LINES OF THE BELL LAND IN INSTRUMENT #67-4758 WERE DETERMINED BY PROPORTIONED DISTANCES ORIENTED TO THE SOUTHERLY LINE OF EDGEWOOD PARK SUBDIVISION.
