Beginning at a 5/8"x30" Iron rod located on the North line of Sec. 21, T28S, R6W, W.M., from which the Sec. Cor. common to Sections 16, 17, 20 & 21 bears S89°48'40"W, 1099.50'ft., Thence N89°48'40"E along said Section line 117.50'ft. to a point; Thence leaving said Section line S11°04'20"E, 168.48'ft. to a 5/8"x30" Iron rod; Thence S78°39'40"W, 115.49'ft. to a 5/8"x30" Iron rod, Thence continuing S78°39'40"W, 115.04'ft. to a point; Thence S11°08'20"E, 229.43'ft. to a 5/8"x30" Iron rod located on the Northerly R/W line of County Road #47; Thence along said County Rd. R/W line N67°24'10"E, 40.87'ft. to a 5/8" Iron rod; Thence leaving said County Rd. R/W line N11°08'20"W, 221.45'ft. to a 5/8"x30" Iron rod; Thence N78°39'40"E, 74.98'ft. to a 5/8"x30" Iron rod; Thence N11°02'30"W, 191.20'ft. to the point of beginning, containing 0.69 Ac. more or less. All situated in the N.W. 1/4, N.W. 1/4, Sec. 21, T28S, R6W, W.M. Douglas County, Oregon.
