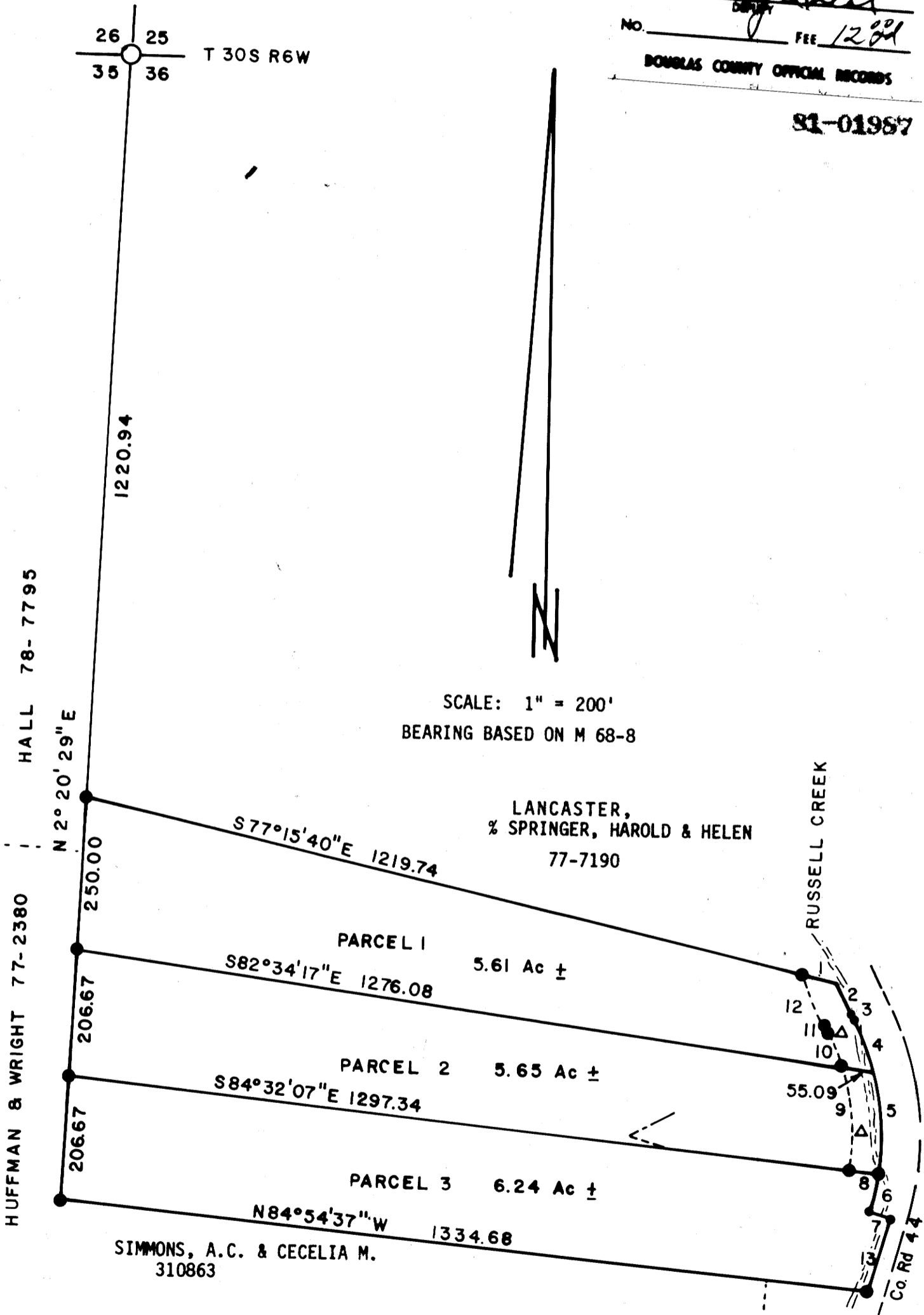

**SURVEY NARRATIVE: EVIDENCE & PROCEDURE**

FOUND MONUMENTS PER M 68-8. USED HAND COMPASS AND STEEL TAPE TO FIND MONUMENTS. MONUMENT POSITIONS WERE NOT CHECKED. ACREAGE CALCULATION  
INCLUDES ANY LAND LYING EAST OF RUSSELL CREEK. THIS AREA IS EXCEPTED BY DEED NO. 76-20429.

**PARCEL 1.**

A PARCEL OF LAND IN SECTION 36, TOWNSHIP 30 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON, CONTAINING 5.61 ACRES MORE OR LESS AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:
