DESCRIPTIONS:

PARCEL ONE:

A parcel of land lying in Section 33, Township 29 South, Range 5 West, Willamette Meridian and being more particularly described as follows:

Beginning at a 5/8" iron rod from which point the East 1/4 Corner of the above said Section 33 bears S 56°38' E 2971.49 feet; thence S 43°14'30" W 317.56 feet to a 5/8" iron rod in a fenceline; thence along said fenceline N 49°59'20" W 520.32 feet to a 5/8" iron rod and N 51°05'19" W 456.38 feet to a fence corner; thence continuing N 51°05'19" W to the South Umpqua River; thence along said South Umpqua River downstream to a point which bears N 51°58'26" W from the point of beginning; thence S 51°58'26" E to a 1/2" iron rod; thence continuing S 51°58'26" E 981.87 feet to the point of beginning and containing 6.8 acres of land, more or less.

Included with the above described parcel of land is an easement, 35 feet in width, the perimeter of which is more particularly described as follows:

Beginning at a 5/8" iron rod at the most easterly corner of the above described parcel from which point the East 1/4 Corner of Section 33, Township 29 South, Range 5 West, Willamette Meridian bears S 56°38' E 2971.49 feet; thence N 68°52'25" E 98.76 feet; thence S 52°42'46" E 125.4 feet, more or less, to the westerly line of U.S. Highway 99; thence along said westerly line southwesterly 25.12 feet, more or less, to a 1" iron pipe and S 33°33' W 10.02 feet; thence N 52°42'46" W 108.94 feet; thence S 68°52'25" W 99.05 feet; thence N 51°58'26" W 23.06 feet to the southeasterly line of the above described parcel; thence along said southeasterly line N 43°14'30" E 35.14 feet to the point of beginning.

PARCEL TWO:

A parcel of land lying in Section 33, Township 29 South, Range 5 West, Willamette Meridian and being more particularly described as follows:

Beginning at a 5/8" iron rod in the westerly line of U.S. Highway 99 from which point the East 1/4 Corner of Section 33, Township 29 South, Range 5 West, Willamette Meridian bears S 63°35'30" E 2810.21 feet; thence along a fenceline N 49°59'20" W 238.04 feet to a 5/8" iron rod; thence N 43°14'30" E 207.68 feet to a 5/8" iron rod; thence S 41°30' E 208.63 feet to a 5/8" iron rod in the above said westerly line; thence along said westerly line S 33°33' W 177.68 feet to the point of beginning and containing 0.978 acres of land, more or less.

PARCEL THREE:

A parcel of land lying in Section 33, Township 29 South, Range 5 West, Willamette Meridian and being more particularly described as follows:

Beginning at a 1" iron pipe in the westerly line of U.S. Highway 99 from which point the East 1/4 Corner of the above said Section 33 bears S 55°40'25" E 2788.66 feet; thence along said westerly line S 33°33'00" W 209.43 feet to a 5/8" iron rod; thence leaving said westerly line N 41°30' W 208.63 feet to a 5/8" iron rod; thence N 43°14'30" E 109.88 feet to a 5/8" iron rod; thence S 51°58'26" E 29.12 feet to a 1 1/4" iron pipe; thence N 68°52'25" E 69.85 feet to a 1" iron pipe; thence S 52°42'46" E 113.89 feet to the point of beginning and containing 0.759 acres of land, more or less.

Included with the above described parcel of land is an easement, 25 feet in width, the perimeter of which is more particularly described as follows:

Beginning at a 1" iron pipe at the most easterly corner of the above described parcel from which the above said East 1/4 Corner of Section 33 bears S 55°40'25" E 2788.66 feet; thence N 52°42'46" W 113.89 feet to a 1" iron pipe; thence S 68°52'25" W 69.85 feet to a 1 1/4" iron pipe; thence N 51°58'26" W 29.12 feet to a 5/8" iron rod; thence N 68°52'25" E 98.76 feet; thence S 52°42'46" E 125.4 feet, more or less, to the westerly line of U.S. Highway 99; thence along said westerly line southwesterly 25.12 feet, more or less, to the point of beginning.
