NARRATIVE:

This survey was performed to survey a two parcel separation off of a 63 acre parcel. The survey was based on the North line of the Lindsey Applegate D. L. C. No. 42. The Northeast corner has been renewed by John Powell, C. S. 56/25. The Northwest corner had been torn out in the course of road construction a number of years ago. Its location was shown in a survey by Oscar Thiel, C. S. 40/265.

I contacted adjacent property owners and ascertained that Grant McCormick, a long time resident and former owner of property North of the lost corner was able to point out the location of the post that replaced the corner stone which marked the Southeast corner of the Elmer Daughtery property. I make this sworn statement a part of this narrative.

I then surveyed between the corners and checked locations and bearing of fences which I note on the map. The North-South lines were rotated to compare to the original deed. The field work was carried on by Kristian DeGroot and Lester Fanning, using a Wild TIAE Theodolite and H. P. 3805A EDM.

PARCEL 1:

Beginning at a 5/8 inch iron rod on the Southerly right-of-way line of County Road No. 63 from which the Northwest corner of the Lindsey Applegate D. L. C. No. 42 bears S. 89°44'28" W. 1952.80 feet; thence along said right-of-way line N. 89°44'28" E. 304.00 feet to a 5/8 inch iron rod; thence S. 0°14'28" W. 924.00 feet to a 5/8 inch iron rod; thence S. 89°44'28" W. 304.00 feet to a 5/8 inch iron rod; thence N. 0°14'28" E. 924.00 feet to the point of beginning. The above described parcel situated in Section 3 T. 23 S., R. 5 W., W. M. and contains 6.45 Acres, more or less.

PARCEL 2:

Beginning at a 5/8 inch iron rod on the Southerly right-of-way line of County Road No. 63, from which the Northwest corner of the Lindsey Applegate D. L. C. No. 42 bears S. 89°44'28" W. 1042.80 feet; thence along said Southerly right-of-way line N. 89°44'28" E. 910.00 feet to a 5/8 inch iron rod; thence S. 0°14'28" W. 924.00 feet to a 5/8 inch iron rod; thence S. 89°44'28" W. 910.00 feet to a 5/8 inch iron rod; thence N. 0°14'28" E. 924.00 feet to the point of beginning. The above described parcel situated in Section 3, T. 23 S., R. 5 W., W. M. and contains 19.30 Acres, more or less.

REMAINING PARCEL:

All of that property described in Inst. No. 71-10991 lying East of Parcel No. 1 described above and contains 37.58 acres more or less.
