BEGINNING AT A 3/4" IRON ROD AT THE NORTHEAST CORNER OF LOT 1, BLOCK 1, CRAIG'S ADDITION, DOUGLAS COUNTY, OREGON; THENCE RUNNING NORTH 87°-32'-35" EAST 255.51 FEET TO A 5/8" IRON ROD AND THERE TERMINATING ON THE WEST LINE OF LOT 82, SCHOOL ADDITION TO THE TOWN OF MYRTLE CREEK, DOUGLAS COUNTY, OREGON, SAID 7/8" IRON ROD BEING SOUTH 0°-05'-00" WEST 7.54 FEET FROM A 1 1/2" IRON PIPE AT THE NORTHWEST CORNER OF SAID LOT 82, SCHOOL ADDITION.
