PARCEL 1:

Beginning at a 1" iron pipe from which the 1/4 Corner common to Sections 33 and 34, Township 27 South, Range 7 West, Willamette Meridian, bears N20°59'10"E 711.02 feet and N89°55'E 1977.51 feet; thence N59°11'W 177.72 feet to a 5/8" iron rod on the southerly right-of-way line of County Road No. 5; thence along an arc of a 756.20 foot radius curve to the right (the chord of which bears N60°40'34"W 44.26 feet) 44.26 feet to a 5/8" iron rod (Engineer's Station 436+81.37 P.T.); thence N58°59'57"W 289.91 feet to a 5/8" iron rod (Engineer's Station 439+71.28 P.C.); thence along an arc of a 676.20 foot radius curve to the left (the chord of which bears N60°44'53"W 41.27 feet) 41.28 feet to a 5/8" iron rod; thence leaving said southerly right-of-way line, S0°01'32"E along a fenceline 427.31 feet to a point on the centerline of Morgan Creek; thence along the centerline of Morgan Creek S54°58'54"E 92.92 feet and S5°35'27"E 127.17 feet and S30°23'03"E 87.64 feet and N78°39'E 228.90 feet; thence leaving said Creek centerline, N18°24'E 374.70 feet to the Point of Beginning, situated in Section 33, Township 27 South, Range 7 West, Willamette Meridian, containing 4.72 acres, more or less.

TOGETHER WITH a 35 foot Roadway Easement as described in Recorder's No. 83-722, Deed Records of Douglas County, Oregon.

PARCEL 2:

Beginning at the 1/4 Corner common to Sections 33 and 34, Township 27 South, Range 7 West, Willamette Meridian, thence S89°55'W 1977.51 feet to a 1/2" iron pipe; thence S20°59'10"W 711.02 feet to a 1" iron pipe; thence S18°24'W 374.70 feet to a point on the centerline of Morgan Creek, being the TRUE POINT OF BEGINNING; thence along the centerline of Morgan Creek S44°23'03"E 113.20 feet and S0°00'20"W 220.00 feet to a point; thence leaving said Creek centerline, N89°49'26"W 436.19 feet to a fence corner (5/8" iron rod set on South side); thence N0°01'32"W 510.00 feet along a fence line to a point on the centerline of Morgan Creek; thence along said centerline S54°58'54"E 92.92 feet and S5°35'27"E 127.17 feet and S30°23'03"E 87.64 feet and N78°39'E 228.90 feet to the TRUE POINT OF BEGINNING, situated in Section 33, Township 27 South, Range 7 West, Willamette Meridian, containing 3.16 acres, more or less.
