BEGINNING AT A 7/8" IRON ROD WHICH IS NORTH 38°11'25" WEST, 490.10 FEET, NORTH 37°34'49" WEST, 190.10 FEET, NORTH 21°04'50" EAST, 217.16 FEET, AND NORTH 87°38'17" EAST, 106.02 FEET, FROM THE QUARTER CORNER COMMON TO SECTIONS 19 & 20, T30S, R5W, W.M.; THENCE NORTH 87°38'17" EAST, 141.69 FEET TO A 3/4" IRON PIPE ON THE WESTERLY HIGH BANK OF THE SOUTH UMPQUA RIVER; THENCE NORTH 87°38'17" EAST, 162.29 FEET MORE OR LESS, TO THE CENTER OF THE SOUTH UMPQUA RIVER; THENCE UPSTREAM ALONG THE CENTER OF THE SOUTH UMPQUA RIVER, NORTH 12°53'47" WEST, 72.67 FEET MORE OR LESS; THENCE NORTH 38°51'17" WEST, 209.94 FEET MORE OR LESS, TO A 3/4" IRON PIPE ON THE WESTERLY HIGH BANK OF THE SOUTH UMPQUA RIVER; THENCE NORTH 38°51'17" WEST, 170.06 FEET TO A 3/4" IRON PIPE ON THE SOUTHERLY RIGHT-OF-WAY OF GAZLEY ROAD; THENCE ALONG THE SOUTHERLY RIGHT-OF-WAY OF GAZLEY ROAD, SOUTH 55°02'40" WEST, 173.16 FEET TO A 1/2" IRON ROD; THENCE SOUTH 18°20'00" EAST, 295.07 FEET TO THE POINT OF BEGINNING, CONTAINING 2.02 ACRES MORE OR LESS.

ROAD EASEMENT

A 35' WIDE ROAD EASEMENT SITUATED IN SECTION 19, TOWNSHIP 30 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON, THE EASTERLY LINE DESCRIBED AS FOLLOWS:

BEGINNING AT A 5/8" IRON ROD WHICH IS NORTH 38°11'25" WEST, 490.10 FEET & NORTH 37°34'49" WEST, 190.10 FEET FROM THE QUARTER CORNER COMMON TO SECTIONS 19 AND 20, T30S, R5W, W.M.; THENCE NORTH 48°46'30" WEST, 58.53 FEET TO A 7/8" IRON ROD; THENCE NORTH 15°41'23" WEST, 270.91 FEET MORE OR LESS TO THE SOUTHERLY RIGHT-OF-WAY OF GAZLEY ROAD AND THERE ENDING.

EASEMENT FOR WELL AND WATERLINE

A 10' WIDE EASEMENT FOR WELL AND WATERLINE SITUATED IN SECTION 19, TOWNSHIP 30 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON, THE CENTERLINE DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT WHICH IS NORTH 38°11'25" WEST, 490.10 FEET, NORTH 37°34'49" WEST, 190.10 FEET AND NORTH 21°04'50" EAST, 31.56 FEET FROM THE QUARTER CORNER COMMON TO SECTIONS 19 AND 20, T30S, R5W, W.M.; THENCE NORTH 10°06'15" WEST, 316.59 FEET MORE OR LESS TO THE NORTHERLY RIGHT-OF-WAY OF GAZLEY ROAD AND THERE ENDING.

SURVEY NARRATIVE

CONTROL AND BASIS OF BEARING: THE POSITIONS OF FOUND MONUMENTS WERE CHECKED BY RADIAL SURVEY AND FOUND TO BE WITHIN 0.15 FEET OF RECORD POSITION. RECORD DISTANCES AND BEARINGS PER M60-51 WERE HELD. THE TIE TO THE QUARTER CORNER OF SECTIONS 19 AND 20 IS RECORD PER M60-51. THE PIPE AND BRASS CAP ARE STILL THERE. THE INVERSED BEARING NORTH 59°20'07" EAST BETWEEN THE NORTHERLY CORNER OF PARCEL 1, AND THE MOST WESTERLY CORNER OF PARCEL 2 WAS HELD FOR CONTROL.

ROAD RIGHT-OF-WAY: THE APPROXIMATE RIGHT-OF-WAY (30' FROM THE CENTER OF THE PRESENT ROAD) PER M60-51 WAS HELD.

EQUIPMENT: T60D LIETZ THEODOLITE, MAC II EDM, AND 100' STEEL TAPE.
