DESCRIPTIONS:

PARCEL 1:

A parcel of land lying in Section 27, Township 27 South, Range 6 West, Willamette Meridian and being a portion of that property described in Volume 249, Page 140 in the Deed Records of Douglas County, Oregon, said parcel being more particularly described as follows:

Beginning at a 5/8" iron rod at the northeast corner of the above said property described in Volume 249, Page 140 in the Deed Records of Douglas County, Oregon, from which point the East 1/4 Corner of the above said Section 27 bears S0°02'55"E 1322.42 feet; thence along the easterly and southerly lines of said property described in Volume 249, Page 140 in the Deed Records of Douglas County, Oregon as follows: S0°02'55"E 50.00 feet to a 5/8" iron rod, S84°03'58"W 248.18 feet to a 1 1/4" iron pipe, S74°01'27"W 118.31 feet to a 5/8" iron rod, S58°26'50"W 266.17 feet to an angle iron, S26°53'15"W 252.96 feet to a 5/8" iron rod, S2°18'30"E 193.54 feet to a 1 1/4" iron pipe, S57°00'20"W 191.02 feet to a 1 1/4" iron pipe, and N88°49'46"W 110.33 feet to a 5/8" iron rod; thence leaving said southerly line North 182.85 feet to a 5/8" iron rod; thence East 23.60 feet to a 5/8" iron rod; thence North 523.91 feet to a 5/8" iron rod in the northerly line of said property described in Volume 249, Page 140 in the Deed Records of Douglas County, Oregon; thence along said northerly line N86°15'38"E 942.90 feet to the point of beginning and containing 5.98 acres of land more or less.

SUBJECT TO an easement, 25 feet in width, 12.5 feet each side of a centerline more particularly described as follows:

Beginning at a point on the Section Line between Sections 26 and 27, Township 27 South, Range 6 West, Willamette Meridian, which is N0°02'55"W 1282.99 feet from the 1/4 Corner common to said Sections 26 and 27; thence along said centerline: N89°00'31"W 123.90 feet, S85°49'26"W 96.30 feet, S76°06'16"W 83.41 feet, S68°29'55"W 149.48 feet, S57°41'01"W 166.78 feet, S27°50'01"W 294.24 feet, S4°55'14"W 160.09 feet, S39°41'05"W 58.86 feet, N62°44'40"W 96.46 feet, N19°48'20"W 79.89 feet, N32°29'45"W 25.20 feet and N74°02'35"W 46.76 feet to the boundary between Parcel 1 and Parcel 2 and there terminating.

PARCEL 2:

A parcel of land lying in Section 27, Township 27 South, Range 6 West, Willamette Meridian and being a portion of that property described in Volume 249, Page 140 in the Deed Records of Douglas County, Oregon, said parcel being more particularly described as follows:

Beginning at a 1 1/4" iron pipe at the southwest corner of the above said property described in Volume 249, Page 140 in the Deed Records of Douglas County, Oregon, from which point the East 1/4 Corner of the above said Section 27 bears S64°22'32"E 1290.74 feet; thence along the westerly and northerly lines of said property described in Volume 249, Page 140 in the Deed Records of Douglas County, Oregon, respectively, N1°09'03"E 689.26 feet to a 1 1/4" iron pipe and N86°15'38"E 208.37 feet to a 5/8" iron rod; thence leaving said northerly line South 523.91 feet to a 5/8" iron rod; thence West 23.60 feet to a 5/8" iron rod; thence South 182.85 feet to a 5/8" iron rod in the southerly line of said property described in Volume 249, Page 140 in the Deed Records of Douglas County, Oregon; thence along said southerly line N88°49'46"W 198.21 feet to the point of beginning and containing 3.34 acres of land, more or less.

TOGETHER WITH an easement, 25 feet in width, 12.5 feet each side of a centerline more particularly described as follows:

Beginning at a point on the Section Line between Sections 26 and 27, Township 27 South, Range 6 West, Willamette Meridian, which is N0°02'55"W 1282.99 feet from the 1/4 Corner common to said Sections 26 and 27; thence along said centerline: N89°00'31"W 123.90 feet, S85°49'26"W 96.30 feet, S76°06'16"W 83.41 feet, S68°29'55"W 149.48 feet, S57°41'01"W 166.78 feet, S27°50'01"W 294.24 feet, S4°55'14"W 160.09 feet, S39°41'05"W 58.86 feet, N62°44'40"W 96.46 feet, N19°48'20"W 79.89 feet, N32°29'45"W 25.20 feet and N74°02'35"W 46.76 feet to the boundary between Parcel 1 and Parcel 2 and there terminating.
