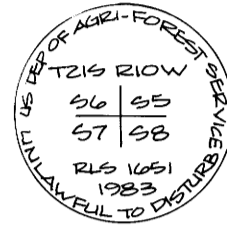

- 40" CEDAR SNAG BEARS N34°E 55.2 FT. (REC. 59.2 FT.) NO VISIBLE MARKS

- 16" D FIR BEARS N44°W 24.3 FT., BLAZED AND SCRIBED "T21S R10W 56 BT"

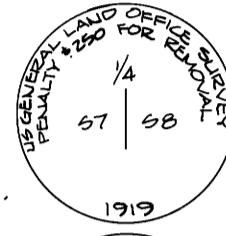

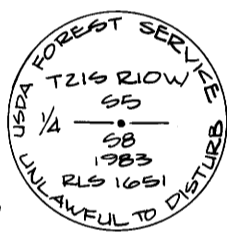

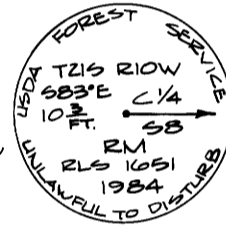

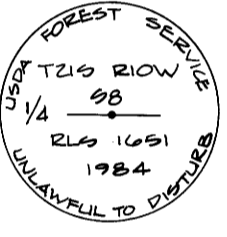

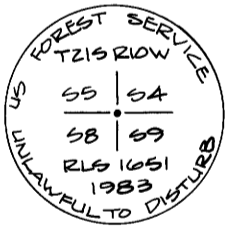

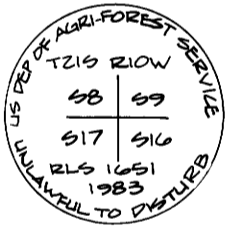
