**DEDICATION**

KNOW ALL MEN BY THESE PRESENTS that we, P.A. Comstock and Etta M. Comstock, his wife, and T.E. Henderson and Effie Henderson, his wife, of Sutherlin, Oregon, owners of the Land through which the hereinafter described roadway runs, hereby dedicate and devote to the use of the public forever for a public road a strip of Land forty (40) feet in width, the Center Line of which is described as follows, to wit: Beginning at a point a 3/4 x 24" Galv. Iron pipe in road leading North from the Fir Grove School House, the N.W. Cor. of The Sutherlin Land and Water Co's BLK 4, PLAT "O", in Section 18 Twp. 25 S. R. 5 W. of the Willamette Meridian, County of Douglas, State of Oregon, from which the S.W. Cor. of the Sutherlin Land and Water Co's BLK 4, PLAT "O" bears South 97° 05' ft; thence N. 89° 18' W. 1946' feet; to a point; thence N. 88° 18' W. 12429 ft. to a point from which the N.E. Cor. C1.54 Twp. 25 S. R. 5 W. of the Will. Mer. Douglas Co Oregon bears North 0° 04' West 11855 feet.

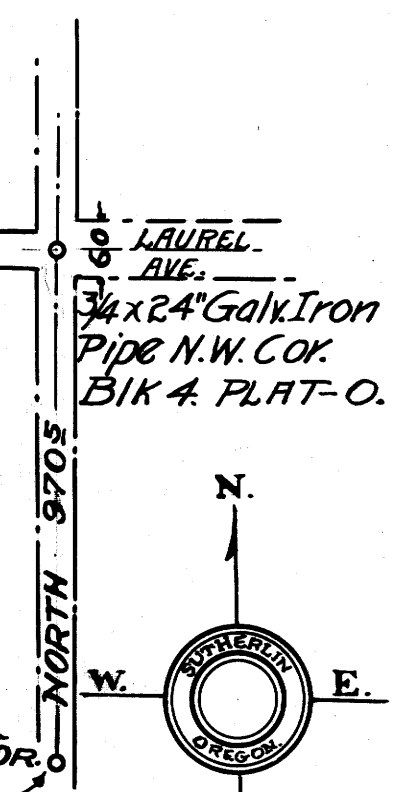
