PARCEL #1

A parcel of land lying in Section 15, Township 28 South, Range 6 West, Willamette Meridian and being a portion of that property described in Instrument #74-15460 as recorded in the Deed Records of Douglas County, Oregon, said parcel being more particularly described as follows: Beginning at a 3/4" iron pipe on the North Line of the above said Section 15 from which point the North 1/4 Corner of said Section 15 bears South 89° 55' 17" East 337.02 feet; thence along the West Line of that property described in Instrument #72-9787 as recorded in the Deed Records of Douglas County, Oregon, South 2° 22' 43" East 720.91 feet to a 5/8" iron rod with cap; thence North 89° 54' 22" West 501.72 feet to a 5/8" iron rod with cap; thence North 0° 00' 39" West 720.11 feet to a 5/8" iron rod with cap on the said North Line of Section 15; thence along said North Line South 89° 55' 17" East 471.94 feet to the point of beginning and containing 8.05 acres of land, more or less.

RESERVING THEREFROM a 60 foot wide parcel of land for roadway purposes, said parcel being 30 feet either side of the following described centerline: Beginning at a point on the North Line of Harmony Lane, said point bears North 89° 55' 17" West 337.02 feet, South 2° 22' 43" East 725.91 feet, and North 89° 54' 22" West 130.00 feet from the North 1/4 Corner of Section 15, Township 28 South, Range 6 West, Willamette Meridian, Douglas County, Oregon; thence North 2° 22' 43" West 420.00 feet; thence along the arc of a 8° curve to the left (the chord of which bears North 11° 30' 03" West 226.27 feet) 227.66 feet; thence along the arc of a curve to the right (the chord of which bears North 17° 04' 26" West 87.84 feet) 87.90 feet to a point on the North Line of that parcel described in Douglas County Deed Records, Instrument #74-15460 and there terminating said point being North 89° 55' 17" West 188.33 feet from the Northeast Corner of said parcel described in Instrument #74-15460.

PARCEL #2

A parcel of land lying in Section 15, Township 28 South, Range 6 West, Willamette Meridian and being a portion of that property described in Instrument #74-15460 as recorded in the Deed Records of Douglas County, Oregon, said parcel being more particularly described as follows: Beginning at a 5/8" iron rod on the North Line of the above said Section 15 from which point the North 1/4 Corner of said Section 15 bears South 89° 55' 17" East 1122.96 feet; thence along said North Line South 89° 55' 17" East 314.00 feet to a 5/8" iron rod with cap; thence South 0° 00' 39" East 720.11 feet to a 5/8" iron rod with cap; thence North 89° 54' 22" West 314.00 feet to a 5/8" iron rod. Thence North 0° 00' 39" West 720.03 feet to the point of beginning and containing 5.19 acres of land, more or less.

PARCEL #3

A parcel of land lying in Section 15, Township 28 South, Range 6 West, Willamette Meridian and being a portion of that property described in Instrument #74-15460 as recorded in the Deed Records of Douglas County, Oregon, said parcel being more particularly described as follows: Beginning at a 5/8" iron rod at the Northwest Corner of that property described in Instrument #74-15460 from which point the North 1/4 Corner of the above said Section 15 bears South 89° 55' 17" East 1317.96 feet; thence along the North Line of said Section 15 South 89° 55' 17" East 195.00 feet to a 5/8" iron rod with cap; thence South 0° 00' 39" East 720.03 feet to a 5/8" iron rod with cap; thence North 89° 54' 22" West 2.99 feet to a 5/8" iron rod with cap; thence along the arc of a 984.93 foot radius curve to the left (the long chord of which bears South 87° 34' 16" West 86.71 feet) 86.74 feet to a 5/8" iron rod with cap; thence South 85° 02' 54" West 105.77 feet to a 5/8" iron rod with cap in the West Line of the above said property described in Instrument #74-15460; thence along said West Line North 0° 00' 39" West 733.09 feet to the point of beginning and containing 3.25 acres of land, more or less.
