A PART OF LOT 28 OF THE 2ND ADDITION TO BRIGGS ACRES IN SECTION 33, TOWNSHIP 29 SOUTH, RANGE 5 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON, THE NORTHEASTERLY LINE OF A 13 FOOT WIDE STRIP WHICH IS DESCRIBED BELOW:

BEGINNING AT THE MOST NORTHERLY CORNER OF SAID LOT 28; THENCE SOUTH 51°18'00" EAST 197.53 FEET MORE OR LESS TO THE MOST EASTERLY CORNER OF SAID LOT 28 AND THERE ENDING.

SURVEY NARRATIVE

BOUNDARY CONTROL: THE BEST FIT OF LOT 28 TO EXISTING MONUMENTS WAS MADE AS FOLLOWS:

BEGINNING AT THE MOST NORTHERLY CORNER OF LOT 28 AS ESTABLISHED BY M59-29, I EXTENDED THE NORTHEASTERLY LINE OF LOT 22 TO INTERSECT AN EXTENSION OF THE NORTHWESTERLY LINE OF MAPLETON HEIGHTS; THENCE ALONG THE NORTHWESTERLY LINE OF MAPLETON HEIGHTS (DISCOUNTING THE MONUMENT 1.92 FEET OFF LINE) RECORD DISTANCE OF 592.65 FEET. THE MOST WESTERLY CORNER OF LOT 28 WAS THEN SET AT RECORD DISTANCE OF 559.5 FEET FROM THE MOST NORTHERLY CORNER OF LOT 28 AND AT PROPORTIONATE DISTANCE 358.75 FT. TO 360.23 FT MEASURED DISTANCE BETWEEN THE MOST SOUTHERLY CORNER OF LOT 28 AND THE MOST WESTERLY CORNER OF LOT 27. THIS FIT PRODUCES A REASONABLY STRAIGHT LINE AND GOOD WIDTH FOR WALNUT STREET.
