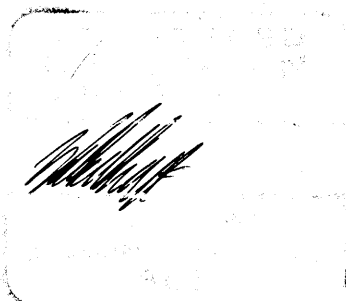
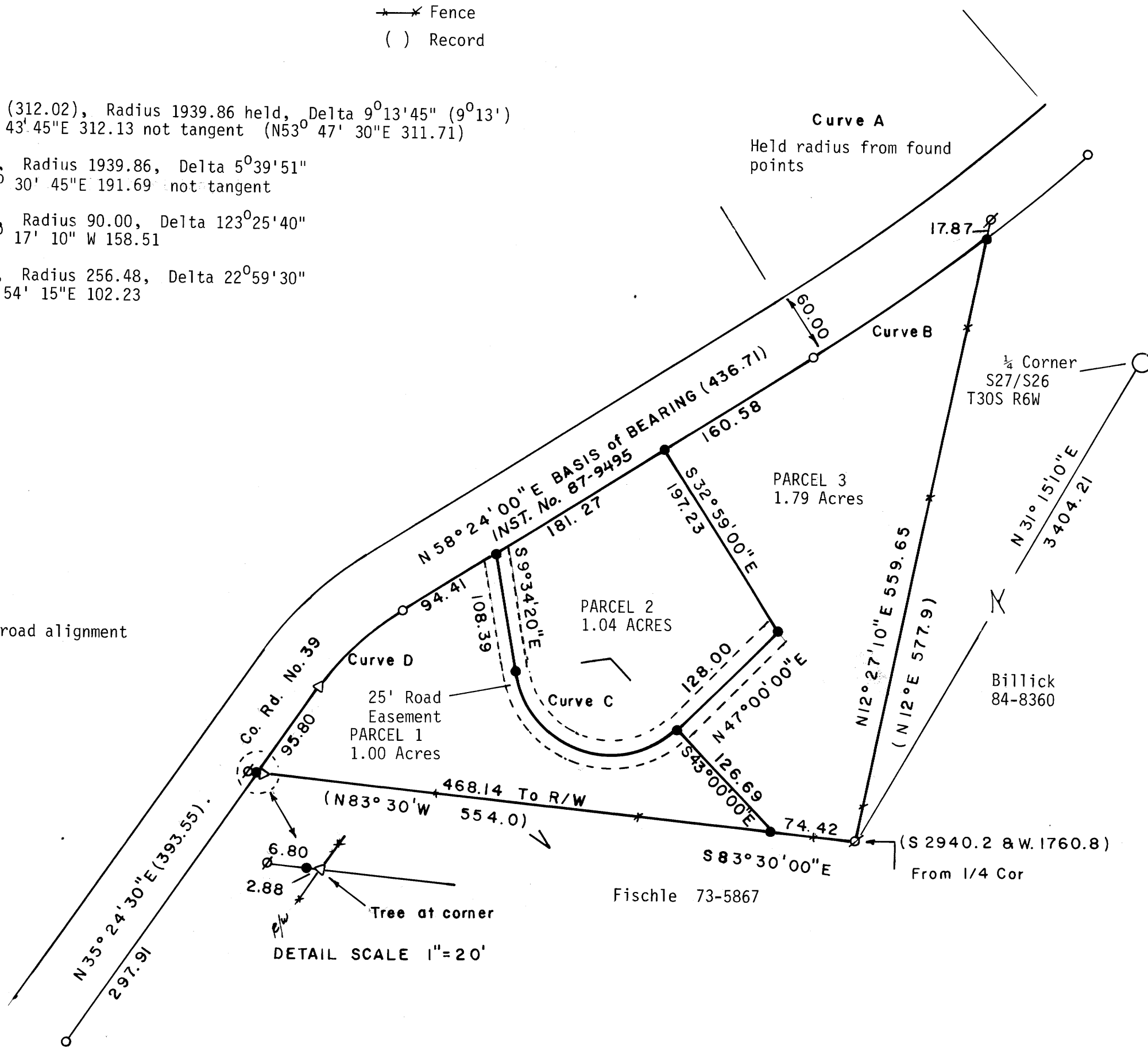


North based on County road alignment

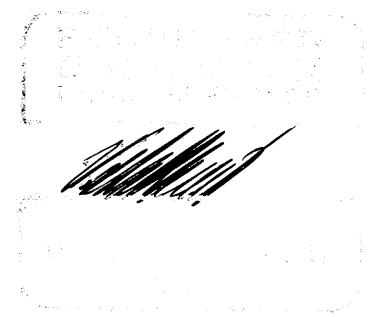
