NARRATIVE:

Parcel 1 and 2 were established from existing monuments as shown on this map. The survey was accomplished by traversing with a Leitz SET 3 Electronic Total Station tying all existing monuments. Computations by Harold V. Stockhoff LS 1663

DESCRIPTIONS:

PARCEL 1

Beginning at a 5/8in. iron rod located on the Northerly Right-of-Way line State Highway No. 38, from which the N.W. cor. of J.F. Levins D.L.C. No. 39 bears N 34° 13' 28" E - 1189.13ft. and N 89° 14' 23" W - 676.61ft., thence along said right-of-way line S56° 14' E - 205.80ft. to an axel with gear attached, thence continuing along said right-of-way S56° 14' E - 8.90ft. to a point, thence leaving said right-of-way line N33° 49' 04" E - 408.60ft. to a 5/8in. iron rod, thence N56° 14' W - 211.80ft. to a 5/8in. iron rod, S34° 13' 28" W - 408.61ft. to the point of beginning. All being situated in the N.W. 1/4, Sec. 19, T22S, R7W, W.M., Douglas County, Oregon.

Excepting there from a Non-Exclusive road easement described below.

Also excepting there from a 10 ft. wide water line easement as described below.

PARCEL 2

Beginning at a iron single tree located on the North boundary of J.F. Levins D.L.C. No. 39, from which the N.W. cor. of said D.L.C. No. 39 bears N89° 14' 23" W - 676.61ft., thence along said D.L.C. No. 39, East 248.27ft. to a 3/4in. drill steel, thence leaving said D.L.C. No. 39, S33° 49' 04" W - 918.48ft. to a 5/8in. iron rod, thence N56° 14' W - 211.80ft to a 5/8in. iron rod, N34° 13' 28" E - 780.52ft. to the point of beginning. All being situated in the N.W. 1/4, Sec. 19, T22S, R7W, W.M., Douglas County, Oregon.

Together with a non-exclusive 25ft. wide road easement for ingress and egress purpose of which the following centerline is described.

Beginning at a point on the Southerly line of Parcel No. 1 70ft. from the S.W. cor. of Parcel No. 1, thence parallel to the Westerly line of Parcel No. 1 to a point on the Northerly line of Parcel No. 1, 70ft. from the N.W. cor. of Parcel No. 1.

Together with a 10 ft. wide water line easement of which the following centerline is described:

Beginning at the existing well on Parcel No. 1, thence N33°49'04"E 320 ft. more or less to a point on the southerly line of Parcel No. 2 from which the Southeast Corner of Parcel No. 2 bears S56°14'E 15.00 ft.
