PARCEL #1

A parcel of land lying in Section 36, Township 28 South, Range 8 West, Willamette Meridian, Douglas County, Oregon, more particularly described as: Beginning at a 5/8" iron rod at the Northeast Corner of that parcel described in Douglas County Deed Records Instrument #78-10470 said point bears South 55° 23' 22" West 1382.45 feet from the East Quarter Corner of said Section 36; thence North 79° 18' 48" West 190.47 feet along the North Line of said parcel to a 5/8" iron rod with cap at the Northwest Corner thereof; thence North 0° 31' 48" East 338.35 feet to a 5/8" iron rod; thence North 89° 25' 20" West 89.85 feet to a 5/8" iron rod; thence North 0° 31' 31" East 96.88 feet to a 5/8" iron rod on the South right-of-way of County Road #250; thence along said right-of-way the following, along the arc or a 942.83 foot radius curve to the right (the chord of which bears North 61° 52' 28" East 144.47 feet) 144.61 feet to a 5/8" iron rod with cap, North 66° 16' East 63.55 feet to a 5/8" iron rod with cap and along the arc of a 395.62 foot radius curve to the left (the chord of which bears North 63° 52' 40" East 32.70 feet) 32.71 feet; thence leaving said right-of-way South 18° 33' 08" East 129.28 feet to a 5/8" iron rod; thence South 18° 33' 07" East 27.11 feet to a 5/8" iron rod with cap; thence South 36° 46' 27" West 90.37 feet to a 5/8" iron rod with cap; thence South 1° 52' 09" West 127.76 feet to a 5/8" iron rod with cap; thence South 1° 35' 37" East 84.93 feet to a 5/8" iron rod; thence South 23° 41' 14" East 159.75 feet to the point of beginning and containing 1.96 acres.

A parcel of land lying in Section 36, Township 28 South, Range 8 West, Willamette Meridian, Douglas County, Oregon, more particularly described as: Beginning at a 5/8" iron rod at the Northeast Corner of that parcel described in Douglas County Deed Records Instrument #78-10470 said point bears South 55° 23' 22" West 1382.45 feet from the East Quarter Corner of said Section 36; thence along the East Line of said parcel described in Douglas County Deed Records Instrument #78-10470 and the West Line of that parcel described in Douglas County Deed Records Instrument #85-7390 the following: South 25° 16' 00" East 115.21 feet to a 5/8" iron rod, South 13° 07' 13" East 206.14 feet to a 5/8" iron rod and South 13° 25' 37" West 60.11 feet to a 5/8" iron rod with cap at the Southwest Corner of that parcel described in Instrument #85-7390; thence along the Southeast and North Lines of said parcel described in Instrument #85-7390 the following: South 84° 32' 09" East 230.27 feet to a 5/8" iron rod, along the arc of a 114.16 foot radius curve to the left (the long chord of which bears North 58° 45' 45" East 136.69 feet) 146.55 feet to a 5/8" iron rod, North 20° 39' 00" West 792.39 feet to a 1/2" iron pipe, North 89° 55' 27" East 321.37 feet to a 3/4" iron pipe, North 0° 35' 04" East 29.89 feet to a 3/4" iron pipe, South 89° 57' 29" West 412.04 feet to a 5/8" iron rod and North 89° 22' 00" West 11.95 feet to a 1/2" iron rod; thence North 18° 33' 08" West 164.80 feet to a 5/8" iron rod, with cap, on the southerly right-of-way of County Road #250; thence along the arc of a 395.62 foot radius curve to the right (the chord of which bears South 57° 01' 08" West 61.94 feet) 62.00 feet to a 5/8" iron rod with cap; thence leaving said right-of-way South 18° 33' 08" East 129.28 feet to a 5/8" iron rod; thence South 18° 33' 07" East 27.11 feet to a 5/8" iron rod with cap; thence South 36° 46' 27" West 90.37 feet to a 5/8" iron rod with cap; thence South 1° 52' 09" West 127.76 feet to a 5/8" iron rod with cap; thence South 1° 35' 37" East 84.93 feet to a 5/8" iron rod; thence South 23° 41' 14" East 159.75 feet to the point of beginning and containing 5.96 acres.
