DESCRIPTIONS

PARCEL 1 Beginning at a 5/8" iron rod from which the SE Corner of Lot 5 Dunham Subdivision bears S 47°09'43" W 170.45 feet; thence N 0°16'25" E 93.29 feet to a 5/8" iron rod; thence S 89°42'00" E 96.50 feet to a 5/8" iron rod; thence S 0°16'36" W 92.95' to a 5/8" iron rod; thence N 89°54'10" W 96.50 feet to the point of beginning, all in the NW 1/4 of Section 21, T28S, R6W, W.M., containing 0.21 acres more or less.

Together with a 25 feet wide access easement described below.

PARCEL 2 Beginning at a 5/8" iron rod from which the SE Corner of Lot 5, Dunham Subdivision bears N 89°54'10" W 96.50 feet and S 47°09'43" W 170.45 feet; thence N 0°16'36" E 92.95 feet to a 5/8" iron rod; thence S 89°42'00" E 215.42 feet to a 5/8" iron rod on the westerly right-of-way line of Civil Bend Avenue; thence along said right-of-way line S 0°08'00" W 29.19 feet to a 5/8" iron rod; thence leaving said right-of-way N 89°54'10" W 119.16 feet to a 5/8" iron rod; thence S 0°08'00" W 63.00 feet to a 5/8" iron rod thence N 89°54'10" W 96.50 feet to the point of beginning, all in the NW 1/4 of Section 21, T28S, R6W, W.M., containing 0.29 acres more or less.

Subject to a 25 feet wide access easement described below.

25 FEET EASEMENT Beginning at a 5/8" iron rod from which the SE Corner of Lot 5, Dunham Subdivision bears S 61°27'33" E 373.70 feet; thence S 89°54'10" E 109.00 feet to a 5/8" iron rod on the westerly right-of-way line of Civil Bend Avenue; thence along said right-of-way line N 0°08'00" E 25.00 feet; thence leaving said right-of-way N 89°54'10" W 215.44 feet; thence S 0°16'36" W 25.00 feet; thence S 89°54'10" E 106.50 feet to the point of beginning.

LOT LINE ADJUSTMENT Beginning at a 5/8" iron rod from which the SE Corner of Lot 5 Dunham Subdivision bears S 61°27'33" E 373.70 feet; thence N 89°54'10" W 10.16 feet to a 5/8" iron rod; thence S 0°08'00" W 63.00 feet to a 5/8" iron rod; thence S 89°54'10" E 10.16 feet to a 5/8" iron rod; thence N 0°08'00" E 63.00 feet to the point of beginning.
