TO A 5/8" IRON ROD, THENCE N 0° 19' 00" E, 407.02 FT. TO A 5/8" IRON ROD, THENCE S 89° 26' 38" E, 574.20 FT. TO A 5/8" IRON ROD, THENCE S 0° 19' 00" W, 672.02 FT.
