THE EAST LINE WAS COMPUTED PER M 35 - 43 AND M 18 - 79. THE SOUTH LINE WAS COMPUTED PER M 18 - 79 AND FOUND MONUMENTS. THE WEST LINE WAS DETERMINED FROM FOUND MONUMENTS.
