Parcel One

A parcel of land situated in Section 4, Township 22 South, Range 5 West, Willamette Meridian, Douglas County, Oregon and being more particularly described as follows:

Beginning at a point marked with a 3/4" x 36" iron rod and from which point the 1/4 corner common to Sections 4 and 9, Township 22 South, Range 5 West, Willamette Meridian bears South 1\*-03'-18" East 499.37 feet and South 89\*-41'-20" West 712.16 feet; thence running North 1\*-03'-18" West 115.59 feet to a point from which a T-iron bears North 1\*-03'-18" West 3.50 feet; thence North 59\*-20'-42" East 330.81 feet to a 3/4" x 36" iron rod; thence South 78\*-29'-07" East 187.18 feet to a 3/4" x 33" smooth iron rod; thence South 1\*-26'-51" East 277.53 feet to a 5/8" x 30" iron rebar; thence North 85\*-49'-35" West 65.12 feet to a 3/4" x 36" iron rod; thence North 11\*-40'-04" West 130.75 feet to a 3/4" x 36" iron rod; thence South 75\*-00'-00" West 394.94 feet to the point of beginning and containing 2.01 acres of land more or less.

TOGETHER WITH A WELL AND WATER LINE EASEMENT.

Parcel Two

A parcel of land situated in Section 4, Township 22 South, Range 5 West, Willamette Meridian, Douglas County, Oregon and being more particularly described as follows:

Beginning at a point marked with a 3/4" x 36" iron rod and from which point the 1/4 corner common to Sections 4 and 9, Township 22 South, Range 5 West, Willamette Meridian bears South 21\*-27'-18" West 475.44 feet and South 89\*-41'-20" West 1316.44 feet; thence running North 85\*-49'-35" West 315.34 feet to a 5/8" x 30" iron rebar; thence North 1\*-26'-51" West 277.53 feet to a 3/4" x 33" smooth iron rod; thence South 78\*-29'-07" East 134.54 feet to a 3/4" x 36" iron rod; thence South 76\*-43'-06" East 196.52 feet to a T-iron; thence South 60\*-45'-50 East 82.82 feet to a 1/2" iron rod; thence South 21\*-27'-18" West 201.93 feet to the point of beginning and containing 2.04 acres of land more or less.

SUBJECT TO A WELL AND WATER LINE EASEMENT.

Well & Water Line Easement

A strip of land, 10 feet wide, 5 feet on each side of a centerline described as follows:

Beginning at a drilled and cased well from which the 1/4 corner common to Sections 4 and 9, Township 22 South, Range 5 West, Willamette Meridian bears North 78\*-00'-00" East 89.50 feet, South 21\*-27'-18" West 677.37 feet and South 89\*-41'-20" West 1316.44; thence running South 14\*-30'-00" West 5.00 feet; thence North 14\*-30'-00" East 34.00 feet; thence North 65\*-30'-50" West 62.00 feet; thence North 76\*-43'-10" West 55.00 feet; thence North 81\*-00'-10" West 80.15 feet; thence North 76\*-32'-00" West 128.94 feet to a point from which a 3/4" x 33" smooth iron rod bears North 1\*-26'-51" West 22.16 feet and there terminating.

Road Dedication

A strip of land, approximately 10 feet wide, situated in Section 4, Township 22 South, Range 5 West, Willamette Meridian, Douglas County, Oregon and being more particularly described as follows:

Beginning at a point marked with a T-iron and from which point the 1/4 corner common to Sections 4 and 9, Township 22 South, Range 5 West, Willamette Meridian bears South 1\*-03'-18" East 618.46 feet and South 89\*-41'-20" West 712.16 feet; thence running North 1\*-03'-18" West 8.00 feet to the southerly line of County Road #68; thence along said southerly line North 59\*-19'-57" East 314.02 feet; thence leaving said southerly line South 78\*-29'-07" East 15.00 feet to a 3/4" x 36" iron rebar; thence South 59\*-20'-42" West 330.81 feet; thence North 1\*-03'-18" West 3.50 feet to the point of beginning and containing 0.07 acres of land more or less.
