PARCEL #1

Beginning at a 5/8" iron rod on the southwesterly right-of-way of Swan Hill, County Road #122 said point also on the East-West Centerline of Section 23, Township 28 South, Range 7 West, Willamette Meridian, Douglas County, Oregon, said point bears South 0° 02' 14" East 2606.66 feet and North 88° 56' 47" West 128.63 feet from the North Quarter Corner of said Section 23; thence along said southerly right-of-way North 55° 49' 16" West 224.66 feet to a 5/8" iron rod with cap, North 61° 52' 58" West 307.10 feet to a 5/8" iron rod with cap, North 75° 13' 43" West 204.75 feet to a 5/8" iron rod with cap and North 62° 53' 14" West 130.99 feet to a 5/8" iron rod with cap; thence leaving said southwesterly right-of-way South 36° 27' 48" West 149.43 feet to a 5/8" iron rod with cap on the high bank of Olalla Creek; thence continuing South 36° 27' 48" West 60.00 feet more or less to the centerline of Olalla Creek; thence South 61° East 222.00 feet and South 75° East 389.45 feet along said centerline of Olalla Creek to a point on the East-West Centerline of said Section 23; thence leaving said centerline and along said East-West Centerline South 88° 56' 47" East 210.36 feet to a 5/8" iron rod with cap, and South 88° 56' 47" East 115.11 feet to the point of beginning and containing 3.42 acres more or less

PARCEL #2

Beginning at a 5/8" iron rod with cap on the North Line of Section 14, Township 28 South, Range 7 West, Willamette Meridian, Douglas County, Oregon, said point bears South 89° 54' 40" West 711.87 feet from the 1/4 Corner common to Sections 14 and 23; thence North 89° 54' 40" East 355.56 feet to a 5/8" iron rod with cap on the West Bank of Olalla Creek; thence continuing along said Section Line North 89° 54' 40" East 40.00 feet to the centerline of Olalla Creek; thence southerly along the centerline of Olalla Creek the following: South 6° West 340.00 feet, South 57° 13' West 586.24 feet, South 74° West 500.00 feet and South 62° West 300.00 feet; thence leaving said centerline of Olalla Creek South 89° 56' West 200.00 feet to a 5/8" iron rod with cap on the easterly right-of-way of Strickland Canyon Road; thence easterly and northerly along said right-of-way its intersection with the North Line of Section 23; thence North 89° 54' 40" East 2.00 feet to the point of beginning.

PARCEL #3

That portion of the Northwest Quarter of Section 23, Township 28 South, Range 7 West, Willamette Meridian, Douglas County, Oregon, lying East of the centerline of Olalla Creek.

EXCEPTING THEREFROM beginning at a 5/8" iron rod on the southwesterly right-of-way of Swan Hill Road, County Road #122 said point also on the East-West Centerline of Section 23, Township 28 South, Range 7 West, Willamette Meridian, Douglas County, Oregon, said point bears South 0° 02' 14" East 2606.66 feet and North 88° 56' 47" West 128.63 feet from the North Quarter Corner of said Section 23; thence along said southerly right-of-way North 55° 49' 16" West 224.66 feet to a 5/8" iron rod with cap, North 61° 52' 58" West 307.10 feet to a 5/8" iron rod with cap, North 75° 13' 43" West 204.75 feet to a 5/8" iron rod with cap and North 62° 53' 14" West 130.99 feet to a 5/8" iron rod with cap; thence leaving said southwesterly right-of-way South 36° 27' 48" West 149.43 feet to a 5/8" iron rod with cap on the high bank of Olalla Creek; thence continuing South 36° 27' 48" West 60.00 feet more or less to the centerline of Olalla Creek; thence South 61° East 222.00 feet and South 75° East 389.45 feet along said centerline of Olalla Creek to a point on the East-West Centerline of said Section 23; thence leaving said centerline and along said East-West Centerline South 88° 56' 47" East 210.36 feet to a 5/8" iron rod with cap, and South 88° 56' 47" East 115.11 feet to the point of beginning and containing 3.42 acres more or less.
