SURVEY NARRATIVE TO COMPLY WITH CHAPTER 209, PARAGRAPH 250, OREGON REVISED STATUTES

SURVEY FOR: Ray Cole and Dick Hess

LOCATION: In Sections 7 & 8, T. 22 S., R. 6 W., W.M., in Douglas County, Oregon.

PURPOSE: To survey and monument the South line of the North 1/2 of the NW 1/4 of Section 8 and the North and West lines of the South 1/2 of the NE 1/4 in Section 7 as shown on the attached map.

PROCEDURE: Control traverses were run to tie in the controlling Government corners as shown. The East and South 1/4 corners of Section 7 were searched for and not found. Bearing trees were marked according to the 1973 B.L.M. Manual and were measured to center of tree at root crown. Monuments set on this survey consist of 5/8" x 30" steel pins with red plastic caps mkd. "D.A. EDWARDS-LS 2339". The bearing trees are situated as follows:
