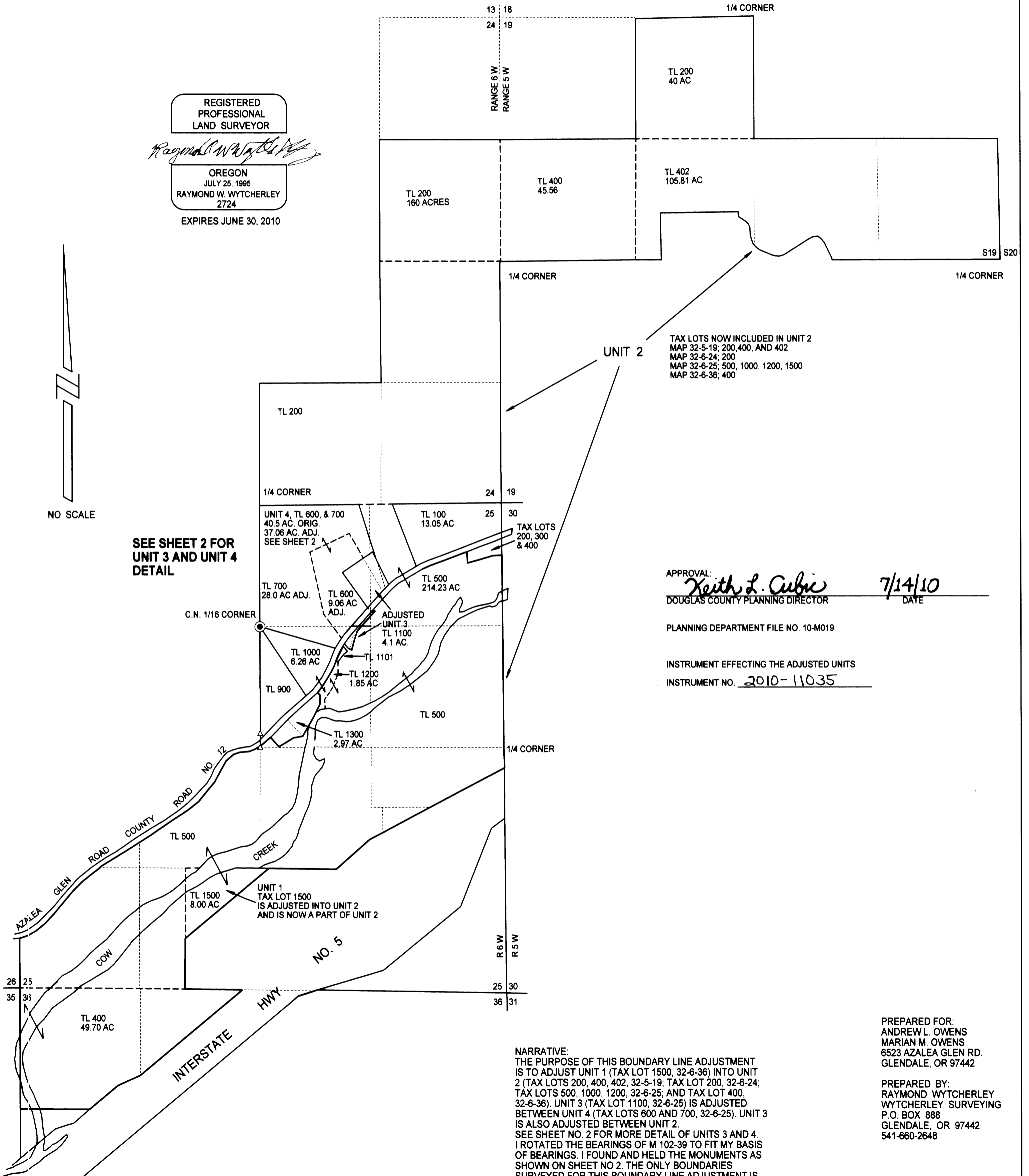

NARRATIVE:

THE PURPOSE OF THIS BOUNDARY LINE ADJUSTMENT IS TO ADJUST UNIT 1 (TAX LOT 1500, 32-6-36) INTO UNIT 2 (TAX LOTS 200, 400, 402, 32-5-19; TAX LOT 200, 32-6-24; TAX LOTS 500, 1000, 1200, 32-6-25; AND TAX LOT 400, 32-6-36). UNIT 3 (TAX LOT 1100, 32-6-25) IS ADJUSTED BETWEEN UNIT 4 (TAX LOTS 600 AND 700, 32-6-25). UNIT 3 IS ALSO ADJUSTED BETWEEN UNIT 2. SEE SHEET NO. 2 FOR MORE DETAIL OF UNITS 3 AND 4. I ROTATED THE BEARINGS OF M 102-39 TO FIT MY BASIS OF BEARINGS. I FOUND AND HELD THE MONUMENTS AS SHOWN ON SHEET NO. 2. THE ONLY BOUNDARIES SURVEYED FOR THIS BOUNDARY LINE ADJUSTMENT IS THE BASIS OF BEARINGS AND THE BOUNDARIES FOR UNIT NO. 3. THIS SURVEY WAS PERFORMED USING A NIKON DTM A-5 TOTAL STATION INSTRUMENT AND A TDS RECON DATA COLLECTOR.
