NARRATIVE:
THE PURPOSE OF THIS BOUNDARY LINE ADJUSTMENT SURVEY IS TO ADJUST THE BOUNDARY BETWEEN TAX LOT 900 (UNIT 2) AND TAX LOT 1000 (A PART OF UNIT 3), AND ADJUSTING THE BOUNDARY BETWEEN TAX LOT 1000 AND TAX LOT 503 (UNIT 1). ALSO ADDING TAX LOTS 1102, SECTION 25, TOWNSHIP 32 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON AND TAX LOT 100, IN THE NORTHEAST QUARTER OF SECTION 35, TOWNSHIP 32 SOUTH, RANGE 6 WEST, WILLAMETTE MERIDIAN, DOUGLAS COUNTY, OREGON ON TO UNIT 3. I SURVEYED TO MARK THE NEW BOUNDARY LINE AND SET THE CORNERS FOR UNIT 1 BY ADDING ON TO MY FORMER SURVEY NO. M 146-29. UNIT 1 IS THE ONLY PARCEL THAT WAS SURVEYED THIS SURVEY. THIS SURVEY WAS PERFORMED USING A NIKON DTM A5 TOTAL STATION AND A RECON DATA COLLECTOR.

NOTE:
THE TAX LOTS IN UNIT 2 OF THE FORMER BOUNDARY LINE ADJUSTMENT ARE NOW A PART OF THE CURRENT UNIT 3.
