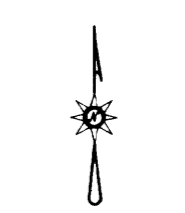
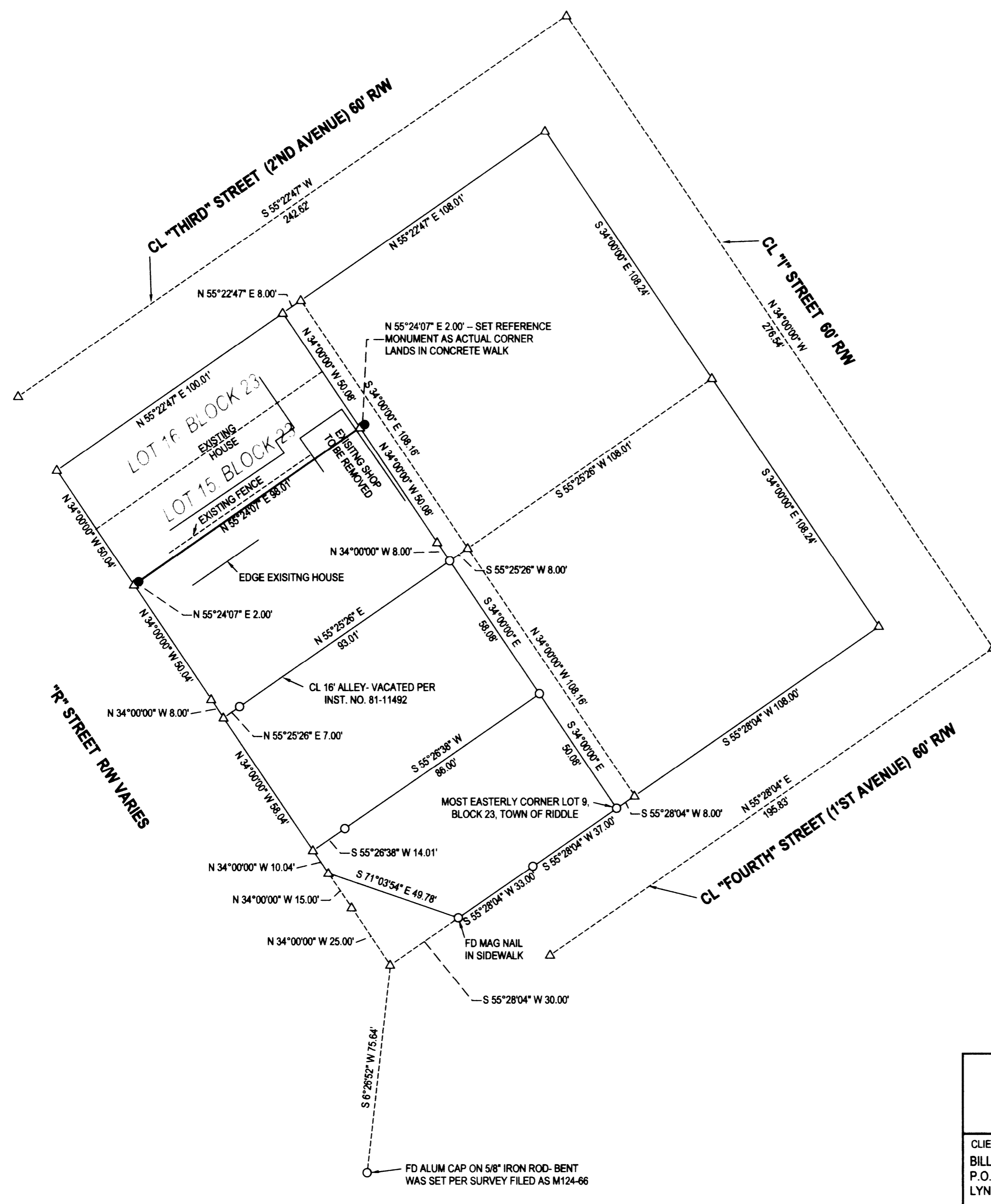

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO MONUMENT THE BOUNDARY BETWEEN LOTS 14 AND 15, BLOCK 23 OF THE TOWN OF RIDDLE. I FILED A PREVIOUS SURVEY AS M 144-58 IN JUNE 2004. THERE HAVE BEEN THREE SUBSEQUENT SURVEYS OF PORTIONS OF THE TOWN OF RIDDLE, THESE SURVEYS FILED AS M150-73, M151-73 AND M155-18. IN LOOKING OVER THESE SURVEYS, I DECIDED TO USE MY PREVIOUS SURVEY, M144-58, AS A BASIS FOR THIS SURVEY WITH BEARINGS AND DISTANCES BETWEEN FOUND MONUMENTS AND PREVIOUSLY SHOWN COMPUTED POINTS BEING RECORD PER M144-58. AS NOTED ON M144-58, UNABLE TO DETERMINE ACTUAL RIGHT-OF-WAY OF "R" STREET. REFERENCE MONUMENTS SET ALONG "R" STREET WERE BEHIND THE EXISTING SIDEWALK AND ARE PROBABLY CLOSE TO THE ACTUAL RIGHT-OF-WAY OF "R" STREET.
