NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE EXTERIOR BOUNDARY OF THAT CERTAIN TRACT OF LAND OWNED BY NORTHWEST PIPELINE CORP. AS DESCRIBED IN WARRANTY DEED, RECORDED IN VOLUME 332 PAGE 346 FOR TAX LOT 2400.

SAID TRACT IS DESCRIBED AS BEGINNING AT A POINT FROM WHICH THE NORTHWEST CORNER OF LOT 10, BLOCK 6 OF PLAT M OF THE SUTHERLIN LAND & WATER COMPANY BEARS NORTH 56°45' WEST, A DISTANCE OF 552.8 FEET AND NORTH 88°21' WEST, A DISTANCE OF 31.02 FEET; THENCE NORTH 33°15' EAST, A DISTANCE OF 318.1 FEET; THENCE SOUTH 88°21' EAST, A DISTANCE OF 74.9 FEET; THENCE SOUTH 33°15' WEST, A DISTANCE OF 318.5 FEET; THENCE NORTH 56°45' WEST, A DISTANCE OF 20.0 FEET; THENCE SOUTH 33°15' WEST, A DISTANCE OF 40.0 FEET; THENCE NORTH 56°45' WEST, A DISTANCE OF 44.3 FEET TO THE POINT OF BEGINNING, CONTAINING 0.481 ACRES, MORE OR LESS.

AFTER REVIEWING THE DEED CALLS IT APPEARS THE INTENT WAS TO MAKE THE EAST AND WEST LINES OF SAID TRACT PARALLEL WITH THE WEST RIGHT-OF-WAY OF A "ROAD WAY" AS SHOWN ON DOUGLAS COUNTY MAP FILE M2-50.

FOR THE WEST LINE OF SAID TRACT, I HELD THE DEED CALL OF 552.8 FEET AND USED A LINE WHICH IS PARALLEL WITH THE WEST RIGHT-OF-WAY LINE OF DOVETAIL LANE AS SHOWN.

THE NORTHWEST CORNER OF LOT 10 OF BLOCK 6 OF PLAT M OF THE SUTHERLIN LAND & WATER COMPANY WAS COMPUTED AS FOLLOWS:

SURVEY FILE M2-50 WAS USED TO COMPUTE THE NORTH LOT LINES OF LOTS 10,11,12 AND 13. ALONG WITH THE RIGHT-OF-WAYS, OF DOVETAIL LANE AND LAUREL AVENUE. MONUMENT NUMBERS 1018, 1024 AND 1025 WERE FOUND AND HELD ALONG WITH A HOT SPOT FOUND AS MONUMENT NO. 1026.

USING MONUMENT NO. 1018 AND 1026 A DISTANCE-DISTANCE METHOD WAS USED TO COMPUTE THE EAST RIGHT OF WAY LINE OF DOVETAIL LANE AND THE INTERSECTION OF THE EAST LINE OF DOVETAIL LANE WITH THE CENTERLINE OF LAUREL AVENUE.

THE WESTERLY RIGHT-OF-WAY OF DOVETAIL LANE WAS COMPUTED BY OFFSETTING 60.00 FEET FROM THE PREVIOUSLY COMPUTED EAST RIGHT OF WAY LINE OF DOVETAIL.

NOTE: SURVEY NO. M2-50 REFERENCES A FENCE LINE ALONG THE EAST AND WEST LINE OF A ROAD WAY, NOW KNOWN AS DOVETAIL LANE, IT IS UNCLEAR IF THE FENCE LINE IS THE RIGHT-OF-WAY LINE. THE DEEDS DO NOT CALL OUT FENCE LINES. FOR THIS SURVEY I DID NOT HOLD SAID FENCE LINE.

FROM SAID INTERSECTION, THE CENTERLINE OF LAUREL AVENUE WAS PROJECTED WEST AT RECORD DISTANCE OF 794.12 FEET TO COMPUTE THE INTERSECTION OF CENTERLINE OF LAUREL AVENUE AND THE NORTHERLY RIGHT-OF-WAY LINE OF HIGHWAY 138.

FROM POINT NO. 1018 A RECORD DISTANCE OF 10.00 FEET WAS COMPUTED ALONG THE EAST LINE OF DOVETAIL LANE. FROM LAST SAID COMPUTED POINT A LINE WAS DRAWN TO MONUMENT 2031 AND THEN PROJECTED NORTHWEST TO INTERSECT WITH THE PREVIOUSLY COMPUTED CENTERLINE OF LAUREL AVENUE. THIS ESTABLISHED THE NORTHERLY RIGHT-OF-WAY LINE OF HIGHWAY 138.

MONUMENTS WERE ALSO FOUND ON THE SOUTH SIDE OF THE HIGHWAY WHICH CLOSELY MATCHED THE RECORD HIGHWAY WIDTHS AS SHOWN.

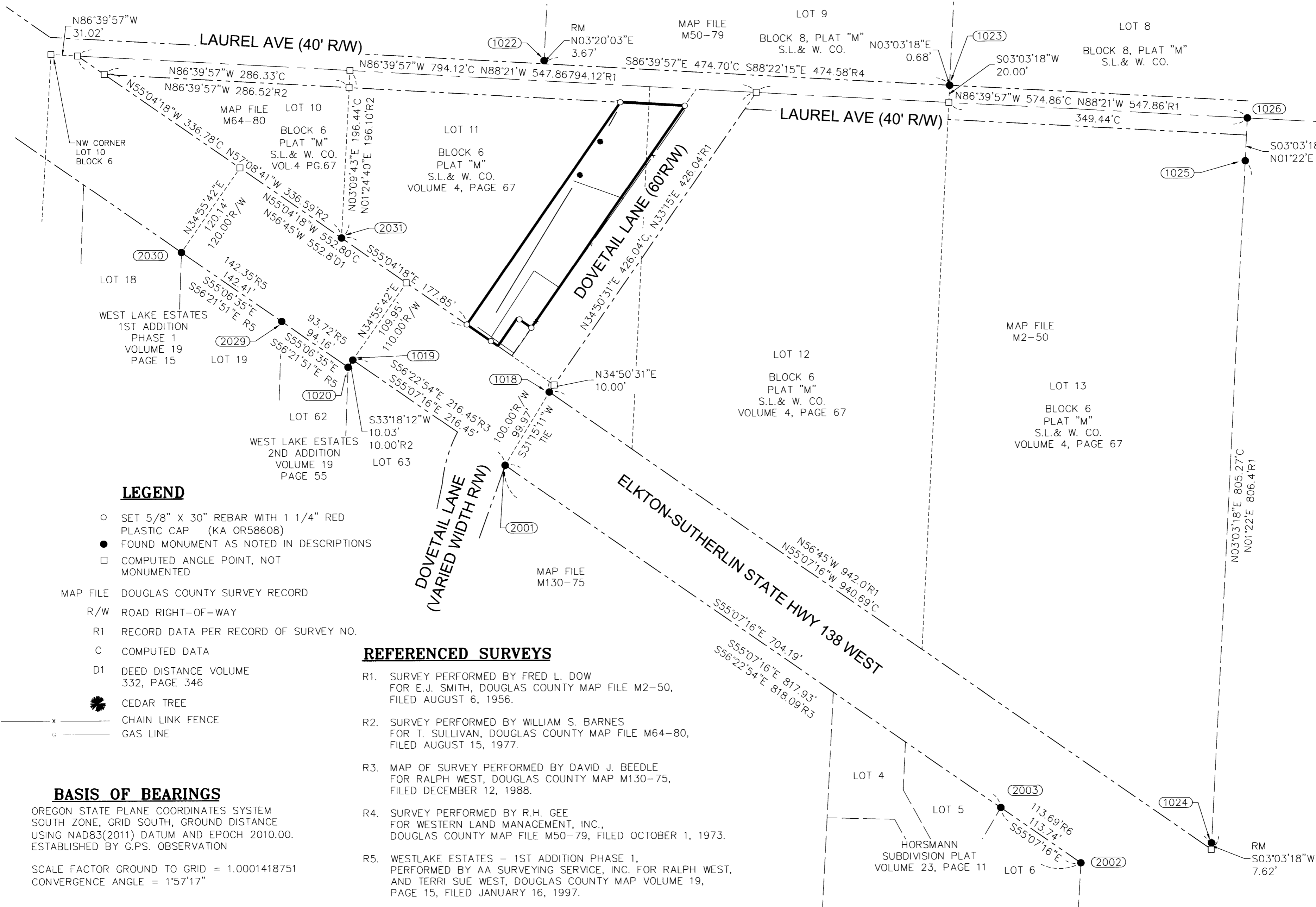

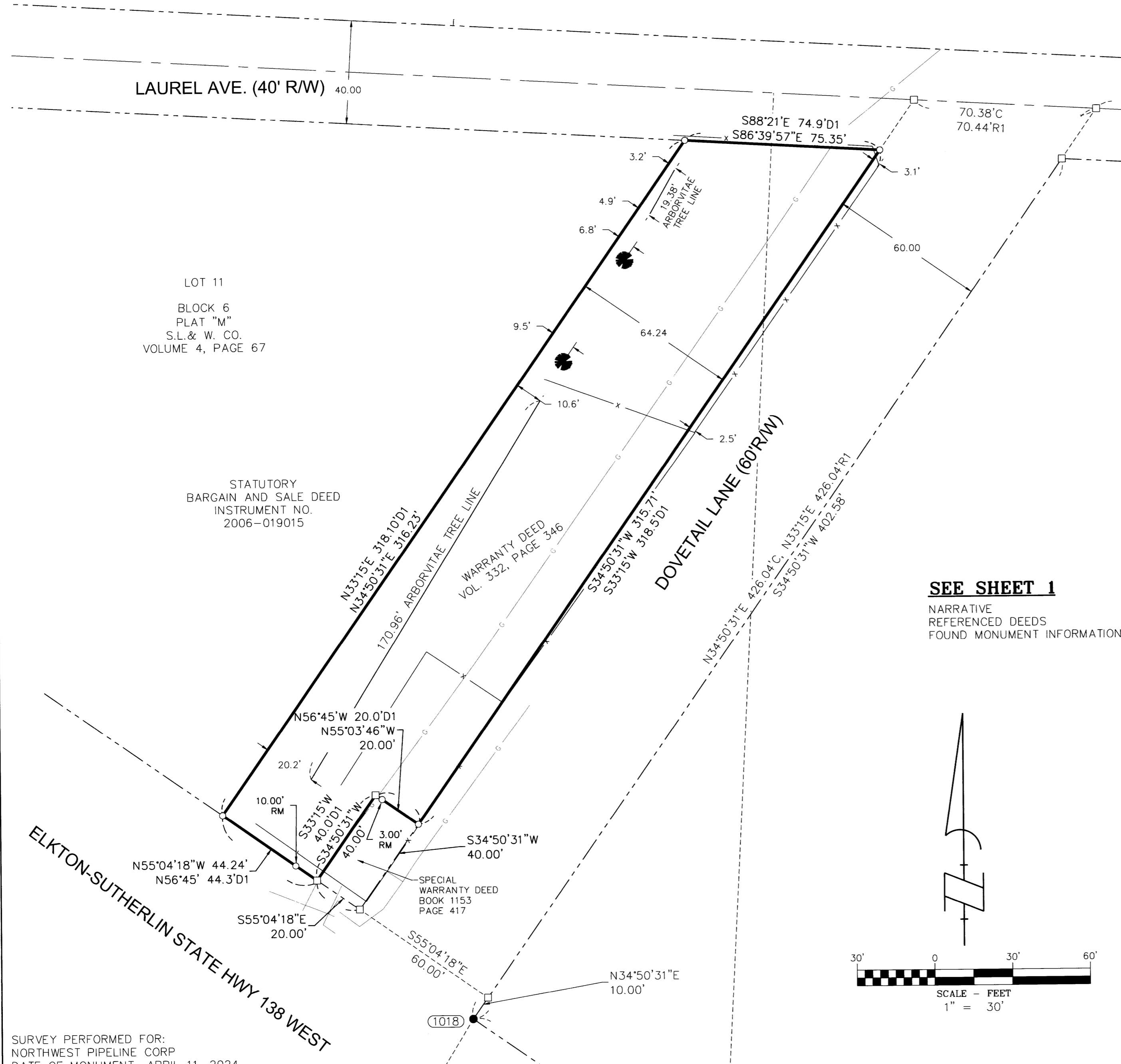
