PARCEL #1

A parcel of land lying in Section 24, Township 27 South, Range 5 West, Willamette Meridian and being a portion of that property described in Instrument #73-245 as recorded in the Deed Records of Douglas County, Oregon, said parcel being more particularly described as follows: Beginning at a 5/8" iron rod on the West Line of the above said Section 24 from which point the West 1/4 Corner of said Section 24 bears North 0° 14' 57" West 82.00 feet; thence leaving said West Line and along the South Line of Buckhorn County Road #4B North 87° 57' 30" East 157.53 feet to a 5/8" iron rod and North 88° 24' 40" East 291.06 feet to a 5/8" iron rod; thence leaving said South Line South 6° 04' 40" East 230.43 feet to a 5/8" iron rod; thence North 87° 18' 09" East 287.70 feet to a 5/8" iron rod; thence South 0° 01' 18" East 554.27 feet to a 5/8" iron rod; thence South 53° 25' 27" West 64.44 feet to a 5/8" iron rod; thence South 74° 17' 43" West 231.98 feet to the centerline of Deer Creek; thence downstream along said centerline as follows: North 46° 56' West 185.40 feet, North 38° 30' West 208.14 feet, North 4° 09' East 128.67 feet, North 63° 06' 30" East 122.61 feet, North 14° 46' East 92.82 feet, North 50° 29' West 223.78 feet, South 88° 36' West 82.00 feet, South 52° 03' West 124.11 feet, and North 84° 59' West 9.16 feet to the above said West Line of Section 24; thence leaving said centerline and along said West Line North 0° 14' 57" West 229.48 feet to the point of beginning and containing 8.52 acres of land, more or less.

PARCEL #2

A parcel of land lying in Sections 23 and 24, Township 27 South, Range 5 West, Willamette Meridian and being a portion of that property described in Instrument #73-246 as recorded in the Deed Records of Douglas County, Oregon, said parcel being more particularly described as follows: Beginning at a point on the West Line of the above said Section 24 and the centerline of Deer Creek from which point the West 1/4 Corner of said Section 24 bears North 0° 14' 57" West 311.48 feet; thence upstream along said centerline of Deer Creek as follows: South 84° 59' East 9.16 feet, North 52° 03' East 124.11 feet, North 88° 36' East 82.00 feet, South 50° 29' East 223.78 feet, South 14° 46' West 92.82 feet, South 63° 06' 30" West 122.61 feet, South 4° 09' West 128.67 feet, South 38° 30' East 208.14 feet, South 46° 56' East 185.40 feet, South 46° 50' 38" East 56.70 feet, and South 4° 55' 37" East 213.16 feet to the South Line of the above said property described in Instrument #73-246; thence along said South Line South 89° 59' 04" West 75.00 feet, South 0° 07' 29" East 119.54 feet and West 1738.84 feet; thence along the West Line of said property described in Instrument #73-246 North 1489.08 feet to the above said centerline of Deer Creek; thence upstream along said centerline as follows: North 70° 00' East 120.00 feet, North 84° 00' East 110.00 feet, South 43° 00' East 65.00 feet, South 3° 00' East 100.00 feet, South 2° 00' East 230.00 feet, South 41° 00' East 100.00 feet, South 86° 15' East 175.00 feet, South 66° 15' East 297.00 feet, North 74° 40' East 236.98 feet, and South 84° 59' East 250.19 feet to the point of beginning and containing 42.22 acres of land, more or less.
